This matter was reviewed by Budget Analyst Joe R. Guerrero on July 10, 2023.

[Timing Considerations]

This recommendation requests the City Manager to provide contributions to California Families in Focus to support the Trans Pride Long Beach Festival. The total appropriation

increase of \$600 in the General Fund Group in the City Manager Department will be offset by a decrease in appropriation of the Third Council District One-Time District Priority Funds and Fourth Council District One-Time District Priority Funds in the General Fund Group in the Citywide Activities Department. This recommendation is anticipated to require a minimal level of staff hours beyond the budgeted scope of duties and is expected to have minimal impact on existing City Council priorities.
