The Economic Development and Finance Committee on April 3, 2007, approved the submission to the Workers' Compensation Appeals Board of Stipulations with Request for Award by the City and Jimmy Brown, based upon an 8 percent disability rating, with provision for lifetime medical care as may be necessary.

Debra Bravo Caston has made a claim for injuries allegedly sustained in the course of her employment with the City of Long Beach. The Economic Development and Finance Committee on April 3, 2007, approved the submission to the Workers' Compensation Appeals Board of Stipulations with Request for Award by the City and Debra Bravo, based upon a 48 percent disability rating, with provision for lifetime medical care as may be necessary.

Jackie Clark has made a claim for injuries allegedly sustained in the course of her employment with the City of Long Beach. The Economic Development and Finance Committee on April 3, 2007, approved the submission to the Workers' Compensation Appeals Board of Stipulations with Request for Award by the City and Jackie Clark, based upon a 19 percent disability rating, with provision for lifetime medical care as may be necessary.

The Economic Development and Finance Committee on April 3, 2007, approved the submission to the Workers' Compensation Appeals Board of Stipulations with Request for Award by the City and Jason Garrido, based upon a 49 percent disability rating, with provision for lifetime medical care as may be necessary.

Humberto Najera has made a claim for injuries allegedly sustained in the course of his employment with the City of Long Beach. The Economic Development and Finance Committee on April 3, 2007, approved the submission to the Workers' Compensation Appeals Board of Stipulations with Request for Award by the City and Humberto Najera, based upon a 25 percent disability rating, with provision for lifetime medical care as may be necessary.

Deborah Rodgers has made a claim for injuries allegedly sustained in the course of her employment with the City of Long Beach. The Economic Development and Finance Committee on April 3, 2007, approved the submission to the Workers' Compensation Appeals Board of Stipulations with Request for Award by the City and Deborah Rodgers, based upon a 13 percent disability rating, with provision for lifetime medical care as may be necessary.
