Recommendation to authorize City Attorney to submit Stipulations with Request for Award for approval by the Workers' Compensation Appeals Board, and if so approved, authority to pay \$111,653.91 for the claim of William Arthur; authority to pay 1) \$27,939.68 and also 2) separate authority to pay \$39,908.47 for the claim of Philip Bernstein; authority to pay \$56,867.50 for the claim of Araceli Thue; and authority to pay \$151,915 for a Stipulations with Request for Award with a life pension thereafter of \$139.15 per week for the claim of Roswitha Winnen-Walker, in compliance with the Appeals Board Orders.

William Arthur has made a claim for injuries allegedly sustained in the course of his employment with the City of Long Beach. The Economic Development and Finance Committee on September 17, 2013, approved the submission to the Workers' Compensation Appeals Board of Stipulations with Request for Award by the City and William Arthur, based upon a 69 percent disability rating, with provision for lifetime medical care as may be necessary;

Philip Bernstein has made a claim for injuries allegedly sustained in the course of his employment with the City of Long Beach. The Economic Development and Finance Committee on September 3, 2013, approved the submission to the Workers' Compensation Appeals Board of two Stipulations with Request for Award by the City and Philip Bernstein, based upon 1) a 26 percent disability rating, with provision for lifetime medical care as may be necessary, and 2) a 33 percent disability rating, with provision for lifetime medical care as may be necessary;

Araceli Thue has made a claim for injuries allegedly sustained in the course of her employment with the City of Long Beach. The Economic Development and Finance Committee on September 3, 2013, approved the submission to the Workers' Compensation Appeals Board of Stipulations with Request for Award by the City and Araceli Thue, based upon a 42 percent disability rating, with provision for

lifetime medical care as may be necessary; and

Roswitha Winnen-Walker has made a claim for injuries allegedly sustained in the course of her employment with the City of Long Beach. The Economic Development and Finance Committee on September 3, 2013, approved the submission to the Workers' Compensation Appeals Board of Stipulations with Request for Award by the City and Roswitha Winnen-Walker, based upon a 96 percent disability rating, with future provision for a life pension at the rate of \$139.15 per week after the permanent disability has been paid, with provision for lifetime medical care as may be necessary.
