Recommendation to authorize City Manager, or designee, to execute an agreement, and any subsequent amendments, with the State of California Department of Public Health, Office of AIDS, to accept and expend funding in the amount of \$241,339 for the provision of HIV/AIDS Health Care/Early Intervention Services, for the period of September 30, 2017 through September 29, 2018. (Citywide)

For the past 29 years, the California Department of Public Health, Office of AIDS (State) has contracted with the City, through the Health and Human Services Department (Health Department), to provide the HIV Care Program (HCP), formally known as the HIV Early Intervention Program (EIP). The HCP provides quality of life enhancement to those individuals infected with, and affected by, HIV. Integrated into HCP services are Early Intervention Services (EIS), which provide additional funding to assist in preventing further transmission and reduce the impact of HIV/AIDS.

The HCP provides comprehensive medical services including diagnostic testing, case management, health education, treatment coordination and advocacy, counseling and specialty referrals, and other direct linkages to outside services as needed. The EIS portion of these services include target testing, referral services, access, linkage and outreach services. Additionally, EIS funding supports data to care activities, including HIV surveillance and disease investigation services. These funds also provide for those who test negative by assisting them into accessing Pre-Exposure Prophylaxis (PrEP). These new funds will increase our client caseload by 100 unduplicated clients per-year. The City still maintains a high incidence and rate of HIV disease. This funding provides for the necessary services to work towards reducing these rates.

This matter was reviewed by Deputy City Attorney Linda T. Vu on November 9, 2017 and by Revenue Management Officer Geraldine Alejo on November 14, 2017.

City Council action is requested on December 5, 2017, as the Health Department started providing services under this contract on September 30, 2017, but is unable to recover costs until the agreements are approved.

The City will receive reimbursement funding up to \$241,339 for the period of September 30, 2017 through September 29, 2018. Sufficient funds are currently appropriated in the Health Fund (SR 130) in the Health and Human Services Department (HE). Subsequent year appropriations will be requested during the annual budget process. No match or in-kind service mandate is required, and there is no local job impact associated with this recommendation.
