Recommendation to increase appropriations in the Special Advertising and Promotion Fund Group in the City Manager Department by \$500, offset by the Sixth Council District one-time District Priority Funds transferred from the Citywide Activities Department to provide a contribution to Jack and Jill of America, Incorporated, Long Beach Chapter for their Far West Region Southern Area Work Day Conference reception; and

On Friday, October 25 and Saturday, October 26, 2019, the Long Beach Chapter of Jack and Jill of America, Incorporated hosted the Far West Region Southern Area Work Day conference at the Long Beach Hilton with over 300 registrants from the Long Beach community.

Jack and Jill of America, Incorporated is a national organization of mothers with children between the ages of 2 - 19. Their mission indicates their dedication to nurturing future African-American leaders by strengthening children through leadership development, volunteer service, philanthropic giving and civic duty. The conference concluded with a reception that brought together community leaders, youth, and provided networking and mentorship opportunities for our Long Beach attendees.

STATEMENT OF URGENCY:

Given that this event has already occurred, approval of this recommendation is needed to ensure a timely contribution to Jack and Jill, Inc. that they may be able to provide payments to vendors who provided services.

This recommendation requests the City Manager Department to provide a contribution to Jack and Jill, Inc., Long Beach Chapter for support of the Far West Region Southern Area Work Day reception. The total appropriation increase in the Special Advertising and Promotion Fund Group in the City Manager Department by \$500 is offset by a decrease of appropriation of Sixth Council District one-time District Priority Funds in the Special Advertising and Promotion Fund Group in the Citywide Activities Department.
