## STATEMENT OF URGENCY

As the Belmont Shore Christmas Parade is being held December 7, 2019, funding is requested prior to the event.

This recommendation requests the City Manager to provide a contribution to the Belmont Shore Business Association to support the televising of the Belmont Shore Christmas Parade. The total appropriation increase of \$2,500 in the Special Advertising and Promotion Fund Group) in the City Manager

Department is offset by a decrease of appropriation of one-time District Priority Funds in the Special Advertising and Promotion Fund Group in the Citywide Activities Department. Implementing this recommendation is anticipated to result in a minimal impact on staff hours beyond normal budgeted scope of duties and a minimal impact on existing City Council priorities.
