- Care Closet LBC in support of their efforts to provide direct assistance to people experiencing homelessness and help facilitate their long-term goals.
- Lakewood Village Neighborhood Organization annual summer concert on August 27th,

2022, to assist with offsetting expenses related to talent fees and promotion of this free community concert.

This matter has been reviewed by Budget Manager Grace H. Yoon on May 26, 2022.

This recommendation requests the City Manager to provide a contribution of \$250 to Cubberley School Foundation, \$1,000 to Care Closet LBC, and \$1,000 to Lakewood Village Neighborhood Association, totaling \$2,250, to support their events and programs as written above. The total appropriation increase of \$2,250 in the General Fund Group in the City Manager Department will be offset by a decrease of appropriation of Fifth Council District One-time District Priority Funds in the General Fund Group in the Citywide Activities Department. This recommendation is anticipated to require a minimal level of staff hours beyond normal budgeted scope of duties and is expected to have a minimal impact on existing City Council priorities.
