2. <u>05-2821</u> Shopping Cart Ordinance referred by substitute motion to the Housing and Neighborhoods Committee for consideration and report back to the City Council in 30 days.

A motion was made by Councilwoman Gabelich, seconded by Councilmember Lerch, that this matter be laid over and request the City Attorney to draft an ordinance requiring all businesses that utilize shopping carts to participate in a mandatory 7-day-a-week retrieval program; establish a progressive policy for non-compliance requiring installation of a containment system; require that all carts be marked or etched with permanent identification that cannot be removed; require that all new stores provide some type of containment system; and return to the Housing and Neighborhoods Committee for review in 30-45 days.
