

**TENTATIVE PARCEL MAP  
CONDITIONS OF APPROVAL  
Case No. 1809-06 (TPM18-002, LCDP18-031)  
December 6, 2018**

1. The approval of this Tentative Parcel Map No. 82379 will result in the division of a single 15,000-square-foot parcel into two separate parcels: Lot 1 – 8,500 square feet and Lot 2 – 6,500 square feet; as per plans filed within the case file.
2. This permit and all development rights hereunder shall terminate three years from the effective date of this permit unless construction is commenced, or a time extension is granted, based on a written request submitted to and approved by the Zoning Administrator prior to the expiration of the three year period as provided in Section 21.21.406 of the Long Beach Municipal Code.
3. This permit shall be invalid if the owner(s) and/or applicant(s) have failed to return written acknowledgment of their acceptance of the conditions of approval on the *Conditions of Approval Acknowledgment Form* supplied by the Planning Bureau. This acknowledgment must be submitted within 30 days from the effective date of approval (final action date or, if in the appealable area of the Coastal Zone, 21 days after the local final action date). Prior to the issuance of a building permit, the applicant shall submit a revised set of plans reflecting all of the design changes set forth in the conditions of approval to the satisfaction of the Zoning Administrator.

**SPECIAL CONDITIONS**

4. The Final Map is to be prepared in accordance with the approved Tentative Parcel Map and shall be recorded within thirty-six (36) months from the date of approval by the Planning Commission of the Tentative Parcel Map, unless prior to expiration of the thirty-six-month period, the Planning Bureau receives a written request from the subdivider for an extension of time, which receives approval from the Zoning Administrator.
5. The Final Map shall be prepared to conform to all conditions, exceptions, and requirements of Title 20 (Subdivision Ordinance) of the City of Long Beach unless specified otherwise herein.
6. Prior to processing of the Final Map, the subdivider shall deposit sufficient funds with the City to cover the cost of processing the Final Map through the Department of Public Works. Furthermore, the subdivider shall pay the Planning processing fees for the Final Map.
7. All County property taxes and all outstanding special assessments shall be paid in full prior to approval of the Final Map.

8. All required off-site street improvements shall be financially provided for to the satisfaction of the Director of Public Works prior to approval of the Final Map.
9. Prior to approval of the Final Map, the applicant shall provide clearance letters from all applicable City departments and other government agencies stating that requirements for subdivision have been met.
10. The property owner shall register the vacant lot with the Department of Development Services, pursuant to Long Beach Municipal Code section 18.29, within thirty days of approval of the Final Map, unless building permits to develop the site have been filed.

#### **STANDARD CONDITIONS**

11. In the event of a transfer of ownership of the property involved in this application, the new owner shall be fully informed of the permitted use and development of the said property as set forth by this permit together with all conditions that are a part thereof. These specific requirements must be recorded with all title conveyance documents at the time of closing escrow.
12. Approval of this subdivision is expressly conditioned upon payment (prior to building permit issuance or prior to Certificate of Occupancy, as specified in the applicable Ordinance or Resolution for the specific fee) of impact fees, connection fees, and other similar fees based upon additional facilities needed to accommodate new development at established City service level standards, including, but not limited to, sewer capacity charges, Park Fees, Transportation Impact Fees, and Housing Trust Fund fees, if applicable.
13. The Director of Development Services is authorized to make minor modifications to the approved design plans or to any of the Conditions of Approval if such modifications shall not significantly change/alter the approved design/project and if no detrimental effects to neighboring properties are caused by said modifications. The Zoning Administrator or Planning Commission shall review any major modifications, respectively.
14. All landscaped areas must be maintained in a neat and healthy condition. Any dying or dead plants materials must be replaced with the minimum size and height plant(s) required by Chapter 21.42 (Landscaping) of the Zoning Regulations. At the discretion of City officials, a yearly inspection shall be conducted to verify that all irrigation systems are working properly and that the landscaping is in good healthy condition. The property owner shall reimburse the City for the inspection cost as per the special building

inspection specifications established by the City Council.

15. The property shall be developed and maintained in a neat, quiet, and orderly condition and operated in a manner so as not to be detrimental to adjacent properties and occupants. This shall encompass the maintenance of exterior facades of the building, designated parking areas serving the use, fences and the perimeter of the site (including all public parkways).
16. Per Section 21.42.030 of the Long Beach Municipal Code, all required yards and setback areas shall be attractively landscaped primarily with live plant material. All landscaped and paved areas shall be maintained in a neat and orderly condition with healthy landscaping free of weeds and litter. The subdivider shall replace all existing dying and dead landscaping on the subject property to the satisfaction of the Director of Development Services prior to approval of the Final Map.
17. As a condition of any City approval, the applicant shall defend, indemnify, and hold harmless the City and its agents, officers, and employees from any claim, action, or proceeding against the City or its agents, officers, or employees to attack, set aside, void, or annul the approval of the City concerning the processing of the proposal/entitlement or any action relating to, or arising out of, such approval. At the discretion of the City and with the approval of the City Attorney, a deposit of funds by the applicant may be required in an amount sufficient to cover the anticipated litigation costs.

## **PUBLIC WORKS CONDITIONS**

### **GENERAL REQUIREMENTS**

18. The final map shall be based upon criteria established by the California Subdivision Map Act and/or Title 20 of the Long Beach Municipal Code.
19. Prior to final map approval, the Subdivider shall obtain utility clearance letters for any public entity or public utility holding any interest in the subdivision as required by the Subdivision Map Act.
20. All facilities required by the Department of Public Works, not in place and accepted prior to final map approval must be guaranteed by the instrument of credit or bond to the satisfaction of the Director of Public Works.
21. Prior to the start of any on-site/off-site demolition or construction, the Subdivider shall submit a construction plan for pedestrian protection, construction area perimeter fencing with custom-printed screen(s), street lane closures, construction staging, shoring excavations and the routing of

construction vehicles (excavation hauling, concrete and other deliveries, etc.).

22. The Subdivider shall construct all off-site improvements needed to provide full ADA accessibility compliance within the adjacent public right-of-way, to the satisfaction of the Director of Public Works. At this stage in the entitlement process, the plans are conceptual in nature, and plan check is required for in-depth review of ADA compliance. As determined during the plan check process, the Subdivider shall dedicate additional right-of-way necessary to satisfy unfulfilled ADA requirements.
23. Public improvements shall be constructed in accordance with Public Works construction standards, and per plans reviewed and approved by the Department of Public Works. The City's Public Works Engineering Standard Plans are available online at [www.longbeach.gov/pw/resources/engineering/standard-plans](http://www.longbeach.gov/pw/resources/engineering/standard-plans). Prior to issuance of a building permit, detailed off-site improvement plans shall be prepared by a licensed Civil Engineer, stamped, signed and submitted to Public Works for review and approval.
24. All conditions of approval, including a cover letter signed by the Planning Officer and Case Planner, must be printed verbatim on all plans submitted for plan review to the Department of Public Works.

#### **PUBLIC RIGHT-OF-WAY**

25. The Subdivider's map shows two new driveway approaches serving the proposed residential units along 1<sup>st</sup> Street. The driveway locations are subject to review and approval by the City Traffic Engineer during review of a future entitlement submittal. The Subdivider shall revise the map and label the respective Site Plan Note as Proposed.
26. The Subdivider shall provide easements to the City of Long Beach for any City required facilities including required slopes, refuse collection access and any other public necessities, to the satisfaction of the public agency or City Department with interest. All easements shall show on the final map.
27. Unless approved by the Director of Public Works, easements shall not be granted to third parties within areas proposed to be granted, dedicated, or offered for dedication to the City of Long Beach for public streets, alleys, utility or other public purposes until the final map filing with the County Recorder. If easements are granted after the date of tentative map approval and prior to final map recordation, a notice of subordination must be

executed by the third-party easement holder prior to the filing of the final map.

### **OFF-SITE IMPROVEMENTS**

28. The Subdivider shall reconstruct the full width of the alley adjacent to the project site with Portland cement concrete, to the satisfaction of the Director of Public Works.
29. The Subdivider shall reconstruct the alley intersection at Kennebec Avenue with Portland cement concrete, to the satisfaction of the Director of Public Works. The Subdivider shall reconstruct the alley intersection to meet full ADA compliance.
30. The Subdivider shall provide for public street lamps or install on-site alley lighting to the improved alley adjacent to the project site, to the satisfaction of the Director of Public Works.
31. The Subdivider shall check with the Long Beach Water Department, at (562) 570-2300, and the Energy Resources Department, at (562) 570-2000, for scheduled main replacement work prior to submitting off-site improvement plans to the Department of Public Works.
32. Subject to the approval of any future driveways, the Subdivider shall provide for the relocation of any existing facilities in conflict with the new points of access, to the satisfaction of the Director of Public Works. The Subdivider shall contact the interested agency or City Department to schedule the relocation work prior to submitting on-site grading plans. Utility plans for relocation shall be submitted to Public Works along with the on-site grading plans, to review and approve.
33. The Subdivider shall remove unused driveways and curb cuts, and replace with full-height curb, curb gutter and sidewalk pavement to the satisfaction of the Director of Public Works. Sidewalk improvements shall be constructed with Portland cement concrete.
34. The Subdivider shall demolish the existing sidewalk and curb ramp located on the corner of Kennebec Avenue and 1<sup>st</sup> Street adjacent to the project site, and construct a new ADA compliant curb ramp to the satisfaction of the Director of Public Works. Sidewalk improvements shall be constructed with Portland cement concrete.

35. The Subdivider shall reconstruct cracked, deteriorated, or uplifted/depressed sections of sidewalk pavement, curb and curb gutter adjacent to the project site, to the satisfaction of the Director of Public Works. Sidewalk improvements shall be constructed with Portland cement concrete. All sidewalk removal limits shall consist of entire panel replacements (from joint line to joint line).
36. The Subdivider shall provide for new street trees with root barriers, ground cover and irrigation system adjacent to the project site, per Section 21.42.050 of the Long Beach Municipal Code. Street trees requiring removal shall be relocated or replaced to the satisfaction of the Director of Public Works. The Subdivider and/or successors shall water and maintain all street trees, landscaping and sprinkler systems required in connection with this project. The Subdivider shall contact the Street Tree Division of the Department of Public Works, at (562) 570-2770, prior to beginning the tree planting, landscaping, and any irrigation system work. The Street Tree Division will assist with the size, type, and manner in which the street trees are to be installed. At a minimum, parkway trees shall provide shade coverage, after five years of growth, of 50% of the total area dedicated for public right of way.
37. The Subdivider shall install Custom Printed Flex Mesh screen(s) along the perimeter of the development site as part of future development, such as FenceScreen.com Series 311, or equivalent, fence screening, and provide for the printed graphics to the satisfaction of the Director of Public Works. The graphics shall depict positive images of the City or other artistic concepts. Prior to submitting the graphic design for printing, the Subdivider shall consult with the Department of Public Works to review and approve.
38. The Subdivider shall be responsible for the maintenance, repair, and replacement of off-site improvements abutting the project boundary during construction of the on-site improvements, until final inspection of the on-site improvements by the City. All off-site improvements, adjacent to the development site and/or along the truck delivery route, found damaged as a result of construction activities shall be reconstructed or replaced by the Subdivider to the satisfaction of the Director of Public Works.
39. The Subdivider shall submit a grading plan with hydrology and hydraulic calculations showing building elevations and drainage pattern and slopes, for review and approval by the Director of Planning and Building Services and the Director of Public Works, prior to approval of the final map.

#### **TRAFFIC AND TRANSPORTATION**

40. The size and configuration of all proposed driveways serving the project site shall be subject to review and approval of the City Traffic Engineer. Contact the Transportation Mobility Bureau, at (562) 570-6331, to request additional information regarding driveway construction requirements.

Note: A single 20-foot wide maximum curb cut is permitted for a lot 0 – 120 feet in width, per Long Beach Municipal Code Section 21.41.253.

41. The Subdivider shall replace all traffic signs and mounting poles that are damaged or misplaced to the satisfaction of the City Traffic Engineer.
42. The Subdivider shall repaint all traffic markings obliterated or defaced to the satisfaction of the City Traffic Engineer.
43. The Subdivider shall contact the Transportation Mobility Bureau, at (562) 570-6331, to modify or refresh the existing curb marking zones adjacent to the project site.

#### **LONG-TERM MAINTENANCE**

44. The Subdivider and successors shall be responsible for the maintenance of the site drainage system, the operation, and maintenance of any private sewer connection to the public sewer in the abutting public right-of-way, and for the maintenance of the sidewalk, parkway, street trees and other landscaping, including irrigation, within and along the adjacent public right-of-way. Such responsibilities shall be enumerated and specified in the project "Conditions, Covenants and Restrictions", and a recorded copy of the said document shall be provided to the Director of Public Works.
