ON-SALE BEER AND WINE LICENSE
LIST OF VOLUNTARY CONDITIONS

- 1) Sales, services and consumption of alcoholic beverages shall be permitted only between the hours of Sunday through Saturday 10:00 a.m. - 2:00 a.m.
- 2) No person under the age of 21 shall sell or package alcoholic beverages.
- 3) A single jukebox or stereo may be maintained upon the premises; however, the music shall not be audible outside the premises.
- 4) There shall be no adult entertainment, as defined by Section 21.15.10 LBMC conducted on the premises.
- 5) The sale of alcoholic beverage for consumption off the premises is strictly prohibited.
- 6) The petitioner shall be responsible for maintaining free of litter the area adjacent to the premises over which he or she has control.
- 7) No alcoholic beverages shall be consumed on any property adjacent to the licensed premises under the control of the licensee.
- 8) The parking area shall be equipped with lighting of sufficient power to illuminate and make easily discernible the appearance and conduct of all persons on or about the parking area. Additionally, the position of such lighting shall not disturb the normal privacy and use of any neighboring residences.
- 9) No pay phone will be maintained on the exterior of the premises.
- 10) Petitioner shall regularly police the area under his or her control in an effort to prevent the loitering of persons about the premises.
- 11) Any graffiti painted or marked upon the premises or on any adjacent area under the control of the licensee shall be removed or painted over within 24 hours of being applied.
- 12) Entertainment provided shall not be audible beyond the area under control of the licensee.
- 13) Video games and coin operated amusement devices maintained upon the premises shall be limited to two (2) dart games, two (2) pool tables and one (1) Megatouch.
