

A RESOLUTION OF THE CITY COUNCIL OF
THE CITY OF LONG BEACH AGREEING TO THE
ACQUISITION OF CERTAIN TAX-DEFAULTED
PROPERTIES IN THE CITY OF LONG BEACH BY THE
LOS ANGELES COUNTY FLOOD CONTROL DISTRICT

WHEREAS, the Los Angeles County Flood Control District has expressed interest in acquiring certain tax-defaulted properties located within the City of Long Beach for flood control purposes, the descriptions and purchase prices of which are attached hereto as Exhibit "A"; and

WHEREAS, the City of Long Beach agrees to said acquisition by the Los Angeles County Flood Control District;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The City of Long Beach agrees to the acquisition of certain taxdefaulted properties located within the City of Long Beach by the Los Angeles County Flood Control District for flood control purposes, the descriptions and prices of which are attached hereto as Exhibit "A".

Sec. 2. The City Manager is hereby authorized to execute an Agreement to Purchase the tax-defaulted properties in favor of the Los Angeles County Flood Control District as set forth herein.

Sec. 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.


