5 minute order adopted by the City Council of the City of Long Beach at its meeting held on
6 May 18, 2010, by and between UNITED STORM WATER, INC., a California corporation,
7 whose address is 14000 East Valley Boulevard, City of Industry, California 91746
8 ("Contractor"), and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the parties entered Agreement No. 31353 whereby Contractor
10 agreed to provide specialized services requiring unique skills to be performed in
11 connection with the Municipal Separate Storm Drain System Maintenance and Repair
12 Services ("Project"); and

13 WHEREAS, the parties desire to increase the Agreement by \$787,000 for a
14 total not to exceed amount of \$1,398,498;

15 NOW, THEREFORE, in consideration of the mutual terms and conditions
16 herein, the parties agree as follows:

18 Agreement No. 31353 are ratified and confirmed and shall remain in full force and effect.
