

FIFTH AMENDMENT TO CONTRACT NO. 29298

THIS FIFTH AMENDMENT TO CONTRACT NO. 29298 is made and entered, in duplicate, as of September 15, 2006 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 19, 2005, by and between RAINBOW HARBOR PARTNERS, LLC, a California limited liability company ("V2O") and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Contract No. 29298 and certain amendments thereto (as amended, the "Contract") whereby City agreed to provide supplemental law enforcement services on an occasional basis to V2O as such services are needed; and

WHEREAS, the parties desire to amend the terms of the Contract;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Contract, the parties agree as follows:

1. The term of the Contract is hereby extended so that the Contract will remain in effect through December 15, 2006.

2. Effective October 1, 2006, the applicable hourly rates for the provision of supplemental services under the Contract shall be as set forth on Exhibit "A" attached hereto.

3. Except as expressly amended herein, all of the terms and conditions of the Contract are ratified and confirmed and shall remain in full force and effect.
