

1 FIRST AMENDMENT TO CONTRACT NO. 34715

3 THIS FIRST AMENDMENT TO CONTRACT NO. 34715 is made, and  
4 entered into, in duplicate, as of January 2, 2018, for reference purposes only, pursuant to  
5 a minute order adopted by the City Council of the City of Long Beach at its meeting held  
6 on December 19, 2017, by and between CAREER DEVELOPMENT SOLUTIONS LLC, a  
7 California limited liability company with offices located at 1900 S. State College Blvd., Suite  
8 100, Anaheim, California 92806 ("Contractor"), and the CITY OF LONG BEACH, a  
9 municipal corporation ("City") and administering entity for Pacific Gateway Workforce  
10 Investment Network.

11 WHEREAS, City and Contractor (the "Parties") entered into Contract No.  
12 34715 whereby Contractor agreed to provide vocational training in various information  
13 technology sectors to Pacific Gateway participants; and

14 WHEREAS, the Parties desire to add \$180,000 for a total not to exceed  
15 Contract amount of \$450,000;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
17 conditions herein contained, the Parties agree as follows:

18 1. Section 5.A of Contract No. 34715 is hereby amended to read as  
19 follows:

20 "A. The total amount which shall be payable by City to Contractor for  
21 Contractor's allowable services during the Term shall not exceed Four Hundred Fifty  
22 Thousand Dollars (\$450,000)."

23 2. Except as expressly modified herein, all of the terms and conditions  
24 contained in Contract No. 34715 are ratified and confirmed and shall remain in full force  
25 and effect.
