1 FIRST AMENDMENT TO CONTRACT NO. 31326

3 THIS FIRST AMENDMENT TO CONTRACT NO. 31326 is made and
4 entered, in duplicate, as of September 30, 2010 for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting held
6 on May 5, 2009, by and between CATHOLIC CHARITIES OF LOS ANGELES, INC., a
7 nonprofit California corporation ("Organization"), with offices located at 1531 James M.
8 Wood Boulevard, Los Angeles, California 90015, and the CITY OF LONG BEACH, a
9 municipal corporation (the "City").

10 WHEREAS, the City has received a grant from the U.S. Department of
11 Housing and Urban Development ("HUD") from the Homelessness Prevention Fund,
12 hereafter referred to as the Homelessness Prevention and Rapid Re-Housing Program
13 ("HPRP"), under Title XII of the American Recovery and Reinvestment Act of 2009, to
14 provide financial assistance and services to either prevent individuals and families from
15 becoming homeless or help those who are experiencing homeless to be quickly re-
16 housed and stabilized; and

17 WHEREAS, as part of Grant Agreement No. S09-MY-06-0522 between
18 HUD and the City (the "HUD Agreement") the City is required to enter into subcontracts
19 with organizations that provide homelessness prevention assistance to households who
20 would otherwise become homeless, many due to the economic crisis, and to provide
21 assistance to rapidly re-house persons who are homeless, and the City has selected
22 Organization as a sub-recipient of grant funds; and

23 WHEREAS, the parties entered Contract No. 31326 whereby Organization
24 agreed to provide this assistance; and

25 WHEREAS, the parties desire to extend the term;

26 NOW, THEREFORE, in consideration of the mutual terms and conditions in
27 the Contract and in this First Amendment, the parties agree as follows:

28 1. Section 3 of Contract No. 31326 is hereby amended to read as

2 "Section 3. The terms of this Contract shall commence at midnight on
3 September 1, 2009, and, unless sooner terminated as provided herein, shall terminate at
4 December 30, 2010. The term of this Contract may be extended by mutual written
5 agreement between the City and Organization. City may reclaim any unused balance of
6 funds for reallocation to other City approved projects."

7 2. Except as expressly amended in this First Amendment, all terms and
8 conditions in Contract No. 31326 are ratified and confirmed and shall remain in full force
9 and effect.
