3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO EXECUTE A CONTRACT WITH DUDEK,
6 WITHOUT ADVERTISING FOR BIDS, TO PROVIDE
7 ENVIRONMENTAL CONSULTING SERVICES, FOR A
8 TOTAL CONTRACT AMOUNT NOT TO EXCEED \$60,000,
9 FOR THE PERIOD OF APRIL 1, 2020 THROUGH MAY 31,

12 WHEREAS, in February 2016, the Department of Development Services
13 engaged the services of Dudek to provide environmental consulting services for the
14 project now known as the Globemaster Corridor Specific Plan (Plan); and

15 WHEREAS, the work was originally authorized under a contract for on-call
16 services, Contract No. 33792, approved by the City Council on December 2, 2014; and

17 WHEREAS, Contract No. 33792 expired on December 31, 2018, but
18 additional work on the Plan was required, so an interim Munis contract was established to
19 ensure continuity of services beginning January 1, 2019; and

20 WHEREAS, while the Plan is nearly complete, there have been delays due
21 in part to the COVID-19 pandemic; and

22 WHEREAS, final job generation, traffic, and air quality analyses are still
23 required to complete the Plan; and

24 WHEREAS, a competitive procurement process for these services is not
25 feasible, because the project is near completion and the remaining tasks build upon prior
26 work and expertise developed by Dudek; and

27 WHEREAS, as a result, no useful purpose would be served by advertising
28 for bids and to do so would constitute an idle and useless act and an unnecessary

1 expenditure of public funds;

2 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
3 follows:

4 Section 1. The above recitals are true and correct and are incorporated
5 herein.

6 Section 2. The City Manager is hereby authorized to execute all
7 documents, and any amendments thereto, with Dudek, to provide environmental
8 consulting services, for a total not to exceed amount of Sixty Thousand Dollars (\$60,000),
9 for a period of one (1) year.

10 Section 3. This resolution shall take effect immediately upon its adoption
11 by the City Council, and the City Clerk shall certify the vote adopting this resolution.

12 I hereby certify that the foregoing resolution was adopted by the City
13 Council of the City of Long Beach at its meeting of December 15, 2020
