RESOLUTION NO. C-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH DESIGNATING THE CITY OF LONG BEACH AS THE ADMINISTERING AGENCY AND SIGNATORY AUTHORITY FOR THE LOCAL WORKFORCE INVESTMENT ACT PROGRAM AND DESIGNATING THE GREATER LONG BEACH WORKFORCE DEVELOPMENT BOARD TO PROVIDE POLICY GUIDANCE AND OVERSIGHT FOR THE PROGRAM

WHEREAS, the City of Long Beach desires to participate in the federal Workforce Investment Act Program (the "Program"); and

WHEREAS, in order to participate in the Program, the State of California, Employment Development Department, requires that a resolution of the City Council be adopted which designates the administering agency and signatory authority for the Program.

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The City Council of the City of Long Beach shall be the administering agency and signatory authority for the Program.

Sec. 2. The City Council of the City of Long Beach designates the Greater Long Beach Workforce Development Board to provide policy guidance and oversight for the Program.

Sec. 3. The City Council of the City of Long Beach acknowledges that the City shall be responsible to the State of California, Employment Development Department, for the expenditure of all funds and liable for those funds not expended in accordance with the Program, and shall return such funds to the State of California,
