#### RESOLUTION NO. C-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO PURCHASE ONE TRACTOR DRAWN AERIAL LADDER TRUCK THROUGH THE CONTRACT BETWEEN THE VILLAGE OF RIDGEFIELD PARK AND SEAGRAVE FIRE APPARATUS, LLC

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City of Long Beach desires to purchase one (1) tractor drawn aerial ladder truck; and

WHEREAS, the Village of Ridgefield Park has a contract for the purchase of this truck through its Contract dated as of December 17, 2003 ("Ridgefield Park Contract"); and

WHEREAS, City's participation in the Ridgefield Park Contract will facilitate acquisition of this truck as well as provide considerable costs benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the Ridgefield Park Contract considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated hereby by this reference.

Sec. 2. The City Manager of the City of Long Beach is hereby authorized to enter an agreement with Seagrave Fire Apparatus, LLC. to purchase one (1) tractor drawn aerial ladder truck of substantially the same type and kind purchased by the City of Ridgefield Park pursuant to the Ridgefield Park Contract except as modified by mutual agreement of the City of Long Beach and Seagrave Fire Apparatus LLC and the purchase by the City of Long Beach shall be on the same terms and conditions afforded to the City of Ridgefield Park in an amount not to exceed \$611,304.00 plus tax, for a period extending until the warranty on the truck expires.

Sec. 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
