FOURTH AMENDMENT TO CONTRACT NO. 35249
35249

THIS FOURTH AMENDMENT TO CONTRACT NO. 35249 is made and entered, in duplicate, as of September 1, 2022 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on May 10, 2022, by and between SULLY-MILLER CONTRACTING COMPANY, a Delaware corporation ("Contractor"), whose address is 135 S. State College Blvd., Suite 400, Brea, California 92821, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Contractor (the "Parties") entered into Contract No. 35249 (the "Contract") whereby Contractor agreed to provide as-needed major and secondary highway construction services, as described in Project Plans and Specifications No. R-7131; and

WHEREAS, the Parties entered into a First Amendment to the Contract to extend the term to April 30, 2021; and

WHEREAS, the Parties entered into a Second Amendment to the Contract to attach an updated rate sheet; and

WHEREAS, the Parties entered into a Third Amendment to the Contract to extend the term to April 30, 2022, add \$5,000,000 for a total not to exceed amount of \$15,000,000, and attach an updated rate sheet; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period, update prevailing wage language, add \$10,000,000 for a total not to exceed amount of \$25,000,000, and attach an updated rate sheet;

NOW, THEREFORE, in consideration of the mutual terms, covenants and conditions herein contained, the Parties agree as follows:

1. Section 2.A. of the Contract is hereby amended to read as follows:

"A. City shall pay to Contractor the amount(s) for materials and work identified in Contractor's Bid for Annual Contract for Major and Secondary Highway (Arterial) Improvements in the City of Long Beach, California, attached

1 hereto as Exhibit "A"; provided, however, that the total compensation to Contractor
2 shall not exceed an annual amount of Twenty-Five Million Dollars (\$25,000,000)
3 during the term of this Contract."

4 2. Section 4 of the Contract is hereby amended to read as follows:

5 "4. TIME FOR CONTRACT. The term of this Contract shall commence
6 at midnight on May 1, 2019, and shall terminate at 11:59 p.m. on April 30, 2023, unless
7 sooner terminated as provided in this Contract, or unless the services or the Project is
8 completed sooner. Time is of the essence hereunder. City will suffer damage if the work
9 is not completed within the time stated, but those damages would be difficult or impractical
10 to determine. So, Contractor shall pay to City, as liquidated damages, the amount stated
11 in the Contract Documents."

12 3. Section 31 is hereby added to the Agreement to read as follows:

13 "31. PREVAILING WAGE RATES. Contractor is directed to pay the
14 general rate of per diem wages for each craft, classification, or type of worker needed to
15 execute the contract (prevailing wage rates). Copies of the current prevailing rate of per
16 diem wages are on file at its principal office (Labor Compliance Division, 411 W. Ocean
17 Boulevard, 6th Floor, Long Beach, California, 90802), and shall be made available to any
18 interested party upon request. The Work will be subject to the **2022-1 prevailing wage**
19 rate, as determined by the Director of the Department of Industrial Relations for the State
20 of California. Contractor is required to post a copy of the determination of the director of
21 the prevailing rate of per diem wages at each job site. Pursuant to Section 1775, Contractor
22 shall forfeit, as a penalty to the City, up to Two Hundred Dollars (\$200) for each laborer,
23 worker or mechanic employed for each calendar day, or portion thereof, that such laborer,
24 worker or mechanic is paid less than the prevailing wage rates for any work done by
25 Contractor, or any subcontractor, under this Contract. The difference between the
26 prevailing wage rates and the amount paid to each worker for each calendar day or portion
27 thereof for which each worker was paid less than the prevailing wage rate shall be paid to
28 each worker by the Contractor or subcontractor.

Contractor is required to pay at least the California minimum wage for the basic hourly rate in all cases where the published prevailing wage rate is below the California minimum wage. Any and all employer payments required by the prevailing wage determinations must also be paid. If the California minimum wage is increased in the future to an amount above that shown in the prevailing wage determination, the basic hourly rate in that determination automatically increases to the new minimum wage."

4. The Rates in Exhibit "A-2" to the Third Amendment are hereby amended in accordance with Exhibit "A-3", attached hereto and incorporated by this reference.

5. Except as expressly amended herein, all terms and conditions in Contract No. 35249 are ratified and confirmed and shall remain in full force and effect.


