

EIGHTH AMENDMENT TO AGREEMENT NO. 34706

THIS EIGHTH AMENDMENT TO AGREEMENT NO. 34706 is made and entered, in duplicate, as of June 29, 2020, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on March 5, 2019, by and between JASON ADDISON SMITH CONSULTING SERVICES, INC. DBA JAS PACIFIC, a California corporation ("Consultant"), with a place of business at 201 North Euclid Avenue, Suite A, Upland, California 91786, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34706 (the "Agreement") whereby Consultant agreed to provide as-needed plan review and inspection services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$34,500 for a total not to exceed amount of \$114,500; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$150,000 for a total not to exceed amount of \$264,500; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to add \$166,300 for a total not to exceed amount of \$430,800; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to add \$181,100 for a total not to exceed amount of \$611,900 and extend the term to July 31, 2020; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to add \$55,100 for a total not to exceed amount of \$667,000; and

WHEREAS, the Parties entered into a Sixth Amendment to the Agreement to update the rates/charges; and

WHEREAS, the Parties entered into a Seventh Amendment to the Agreement to add \$40,000 for a total not to exceed amount of \$707,000; and

WHEREAS, the Parties desire to add \$150,000 to the Agreement for a total

1 not to exceed amount of \$857,000 and extend the term one (1) additional one-year period;

2 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
3 conditions herein contained, the Parties agree as follows:

4 1. Section 1.A. of the Agreement is hereby amended to read as follows:

5 "A. Consultant shall furnish specialized services more particularly
6 described in Exhibit "A", attached to this Agreement and incorporated by this reference, in
7 accordance with the standards of the profession, and City shall pay for these services in
8 the manner described below, not to exceed Eight Hundred Fifty-Seven Thousand Dollars
9 (\$857,000), at the rates or charges shown in Exhibit "B"."

10 2. Section 2 of the Agreement is hereby amended to read as follows:

11 "2. TERM. The term of this Agreement shall commence at midnight on
12 August 1, 2017, and shall terminate at 11:59 p.m. on July 31, 2021, unless sooner
13 terminated as provided in this Agreement, or unless the services or the Project is
14 completed sooner."

15 3. Except as expressly amended herein, all terms and conditions in
16 Agreement No. 34706 are ratified and confirmed and shall remain in full force and effect.
