3 AN ORDINANCE OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AMENDING THE LONG BEACH
5 MUNICIPAL CODE BY AMENDING SUBSECTION
6 14.20.200 (C) RELATING TO NEWSRACKS IN BELMONT
7 SHORE

9 WHEREAS, the City Council finds that Belmont Shore is a unique part of
10 Long Beach, containing features which attract visitors from all over Long Beach and
11 surrounding cities, and

12 WHEREAS, both residents and visitors contribute to both pedestrian
13 and vehicular traffic in Belmont Shore, and

14 WHEREAS, both residents and visitors enjoy using the sidewalks of
15 Second Street in Belmont Shore, and

16 WHEREAS, a pilot program initiated in 1997 to regulate the appearance
17 and location of newsracks has improved the appearance of the sidewalk area as well
18 as the overall appearance of Second Street, and

19 WHEREAS, the pilot program improved pedestrian and traffic safety on
20 Second Street by maintaining clearer sight lines for both pedestrians and drivers.

21 NOW THEREFORE, the City Council of the City of Long Beach ordains
22 as follows:

23 Section 1. Section 14.20.200 (C) of the Long Beach Municipal Code is
24 amended to read as follows:

25 C. This section shall cease to be of any effect on July 1, 2007
26 unless extended.

27 Sec. 2. If any portion of this ordinance is held to be invalid, illegal, or
28 unconstitutional by a court of competent jurisdiction, such decision shall not affect the

1 validity of the remaining portions of this ordinance.


2 Sec. 3. The City Clerk shall certify to the passage of this ordinance by
3 the City Council of the City of Long Beach and cause it to be posted in three
4 conspicuous places in the City of Long Beach, and it shall take effect on the thirty-first
5 day after it is approved by the Mayor.
