3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH AUTHORIZING THE CITY  
5 MANAGER TO EXECUTE A CONTRACT, AND ANY  
6 AMENDMENTS THERETO, WITH MEDPRO WASTE  
7 DISPOSAL, LLC WITHOUT ADVERTISING FOR BIDS FOR  
8 SHARPS KIOSKS AND COLLECTION SERVICES IN AN  
9 ANNUAL AMOUNT NOT TO EXCEED \$14,400

11 WHEREAS, the Department of Health and Human Services will partner with  
12 the Departments of Parks, Recreation and Marine, Police and Fire to initiate a pilot  
13 program to reduce the presence of hypodermic needles and other hazardous materials at  
14 City beaches, parks, and public places; and

15 WHEREAS, the pilot program aligns with Council requests in the CD3  
16 Report Request on Beach Enforcement on August 14, 2018; and

17 WHEREAS, MedPro Waste Disposal, LLC ("MedPro") was chosen to  
18 provide collection services for the City of Long Beach because the firm provided the  
19 lowest upfront annual cost out of the multiple quotes received and was willing to accept  
20 the City's proposed kiosk locations; and

21 WHEREAS, out of the firms assessed, MedPro is the only firm that accepts  
22 other non-sharp material, such as trash or pharmaceuticals, that may be improperly  
23 transferred to the bins; and

24 WHEREAS, MedPro allows for the City to directly rent kiosks, and will  
25 provide free maintenance should the bins sustain damage; and

26 WHEREAS, contracts at the requested dollar amount do not customarily  
27 require City Council approval. However, given the nature of the services, a formal  
28 contract has been drafted by MedPro to ensure proper documentation and application of

1 the scope of work; and

2 WHEREAS, as a result, no useful purpose would be served by advertising  
3 for bids and to do so would constitute an idle and useless act and an unnecessary  
4 expenditure of public funds;

5 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
6 follows:

7 Section 1. The above recitals are true and correct and are incorporated  
8 herein.

9 Section 2. The City Manager is hereby authorized to enter a contract,  
10 and any amendments thereto, with MedPro Waste Disposal, LLC to provide sharps  
11 kiosks and collection services at various locations throughout the City of Long Beach in  
12 an annual amount of Eleven Thousand Five Hundred Twenty Dollars (\$11,520), including  
13 a twenty-five percent (25%) contingency of Two Thousand Eight Hundred Eighty Dollars  
14 (\$2,880), for a total annual contract amount not to exceed Fourteen Thousand Four  
15 Hundred Dollars (\$14,400), for a period of one-year, with the option to renew for four (4)  
16 additional one-year periods, at the discretion of the City Manager.

17 Section 3. This resolution shall take effect immediately upon its adoption  
18 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
