THIS CONSENT TO ASSIGNMENT AND ASSUMPTION OF CONTRACT NO. 34780 is made and entered into this 3rd day of September, 2020, by and among the CITY OF LONG BEACH, a municipal corporation, with its principal place of business located at 411 West Ocean Blvd., Long Beach, California 90802 ("City"); GENUINE PARTS COMPANY, a Georgia corporation with its principal place of business located at 2999 Wildwood Parkway, Atlanta, GA 30339 ("Assignor") and SOCAL AUTO & TRUCK PARTS INC., a Georgia corporation with its principal place of business located at 1422 N. Batavia St., Orange, CA 92867 ("Assignee").

WHEREAS, the City requires the furnishing and delivery of general automotive parts for maintenance of a wide variety of vehicles and equipment used by City Departments, including the Water and Harbor Departments; and

WHEREAS, on October 30, 2017 City entered into Contract No. 34780 with Assignor whereby Assignor agreed to furnish and deliver general automotive parts; and

WHEREAS, Assignee purchased all of the assets of the Assignor owned stores at certain locations per the Bill of Sale dated March 1, 2019; and

WHEREAS, as part of the purchase, Assignee assumed substantially all of the contracts related to these certain locations, including Contract No. 34780; and

WHEREAS, Assignor desires to assign to Assignee, and Assignee desires to assume from Assignor, Contract No. 34780 between Assignor and the City, with all the rights and responsibilities enumerated therein; and

WHEREAS, City desires to consent to this Assignment and Assumption;

NOW, THEREFORE, in consideration of the mutual promises, covenants, guaranties and conditions contained in this Agreement, the parties agree as follows:

1. Assignor has granted, conveyed and transferred its assets to Assignor, including its rights and obligations under Contract No. 34780 with the City of
