

1 FIRST AMENDMENT TO AGREEMENT NO. 33915

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33915 is made and
4 entered, in duplicate, as of June 12, 2017 for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on June 2, 2015,
6 by and between FRANK R. WEBB ARCHITECTS, INC., a California corporation
7 (“Consultant”), with a place of business at 8607 Venice Boulevard, Los Angeles, California
8 90034, and the CITY OF LONG BEACH, a municipal corporation (“City”).

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with as-needed architectural services; and

11 WHEREAS, City and Consultant (the “Parties”) entered into Agreement No.
12 33915 (the “Agreement”) whereby Consultant agreed to provide these services; and

13 WHEREAS, the Parties desire to extend the term an additional one (1) year
14 period;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the Parties agree as follows:

17 1. Section 2 of the Agreement is hereby amended to read as follows:

18 “2. TERM. The term of this Agreement shall commence at midnight on
19 July 20, 2015, and shall terminate at 11:59 p.m. on July 19, 2018, unless sooner terminated
20 as provided in this Agreement, or unless the services or the Project is completed sooner.
21 The parties have the option to extend the term for two (2) additional one-year periods.”

22 2. Except as expressly modified herein, all of the terms and conditions
23 contained in Agreement No. 33915 are ratified and confirmed and shall remain in full force
24 and effect.
