THIS FIRST AMENDMENT TO AGREEMENT NO. 35200 is made and entered, in duplicate, as of November 21, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 8, 2019, by and between THE LITTLE LION FOUNDATION, a California nonprofit organization ("LLF"), with an office located at 233 West Artesia Blvd., Long Beach, CA 90805, HELEN SANDERS CAT PROTECTION AND WELFARE SOCIETY, a Colorado nonprofit organization ("CatPAWS"), with an office located at 1198 Pacific Coast Highway, Suite D-227, Long Beach, CA 90740, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services to operate and manage a Kitten Nursery to nurse Long Beach Animal Care Services provided kittens through to adoptable health and age. ("Project"); and

WHEREAS, the parties entered Agreement No. 35200 whereby LLF and CatPAWS agreed to provide these services; and

WHEREAS, the parties desire to extend the term of the Agreement;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

1. Section IV. of Agreement No. 35200 is hereby amended to read as follows:

"The term of this Agreement shall commence on January 1, 2019, and shall terminate on March 31, 2020. Upon written amendment to agreement signed by all parties, the Agreement may be renewed on an annual basis through December 31, 2023. If renewed, the Agreement shall be reviewed in December each year to ensure that all terms are being met and to make any necessary revisions."
