THIRD AMENDMENT TO CONTRACT NO. 34622

THIS THIRD AMENDMENT TO CONTRACT NO. 34622 is made and entered into, in duplicate, effective as of April 3, 2020, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on December 19, 2017, by and between LONG BEACH MEMORIAL MEDICAL CENTER, a non-profit for public benefit corporation with offices located at 2901 Atlantic Avenue, Long Beach, California 90807 ("Contractor") and the CITY OF LONG BEACH, a municipal corporation ("City") and administering entity for Pacific Gateway Workforce Investment Network.

WHEREAS, City and Contractor (the "Parties") entered into Contract No. 34622 (the "Contract") whereby Contractor agreed to provide customized training for patient care assistants, including work experience hours, to program participants; and

WHEREAS, the Parties entered into a First Amendment to the Contract to extend the term to December 31, 2018 and add \$350,000 for a total not to exceed amount of \$670,000; and

WHEREAS, the Parties entered into a Second Amendment to the Contract to extend the term to December 31, 2019; and

WHEREAS, the Parties desire to exercise their second and final option to extend the term of the Contract one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2.A. of Contract No. 34622 is hereby amended to read as follows:
 - "A. The term of this Contract ("Term") shall be deemed to have commenced as of November 1, 2016, and unless sooner terminated pursuant to the provisions hereof, shall terminate on December 31, 2020. Either of the Parties hereto shall have the right to terminate this Contract in its entirety at any time during

the Term for any or no reason whatsoever by giving fifteen (15) days prior written notice of termination to the other party. City shall have the additional right to cancel any part of this Contract at any time during the Term for any reason whatsoever by giving fifteen (15) days' notice of such cancellation to the Contractor."

 Except as expressly modified herein, all of the terms and conditions contained in Contract No. 34622 are ratified and confirmed and shall remain in full force and effect.
