## SECOND AGREEMENT AMENDING RECREATION PARK OIL AND GAS LEASE

KNOW ALL MEN BY THESE PRESENTS: That the following agreement is made and entered into this 5th day of march, 1970, by and

BETWEEN

CITY OF LONG BEACH, a municipal corporation,

and

ALAMITOS LAND COMPANY, a California corporation, (hereinafter referred to collectively as "Lessors"),

HERBELL OIL EXPLORATION COMPANY, a limited partnership, (hereinafter referred to as "Lessee"),

## WITNESSETH:

Under date of September 6, 1962, City of Long Beach and Alamitos Land Company, as lessors, and J. A. Campbell, H. H. Herder and Herbell Oil Exploration Company, a general partnership, as lessee, entered into that certain Recreation Park Oil and Gas Lease, hereinafter referred to as "said lease".

By an assignment dated September 6, 1962, all right, title and interest of J. A. Campbell, H. H. Herder and Herbell Oil Exploration Company, a general partnership, the lessee in said lease, was assigned, transferred and conveyed to Herbell Oil Exploration Company, a limited partnership formed under the laws of the State of California by a Limited Partnership Agreement made and entered into as of the 6th day of September, 1962, and Ralph K. Campbell, M. D., Malcolm E. Campbell and H. H. Herder are now the general partners in said limited partnership.

The First Agreement Amending Recreation Park Oil and Gas Lease, dated September 15, 1959, settled certain differences among the parties. Such amendment inadvertently contained an

3	nants and agreements herein contained, the parties hereto agree

5	1. Subparagraph (2) of Subdivision A of Paragraph 12,

7	lease, as amended by the First Agreement Amending Recreation
8	Park Oil and Gas Lease, is corrected to read:
9	"(2) One Hundred Twenty Dollars (\$120.00)
10	per well per month for the first five
11	(5) producing wells."
12	The above amendment of said Subparagraph (2) shall be
13	effective retroactively to January 1, 1969.
14	2. This agreement shall become effective
15	March 5, 1970, and said lease, as hereby
16	corrected, shall continue in full force and effect.
