1 FIRST AMENDMENT TO CONTRACT NO. 34622

3 THIS FIRST AMENDMENT TO CONTRACT NO. 34622 is made and entered
4 into, in duplicate, effective as of December 21, 2017, for reference purposes only, pursuant
5 to a minute order adopted by the City Council of the City of Long Beach at its meeting held
6 on December 19, 2017, by and between LONG BEACH MEMORIAL MEDICAL CENTER,
7 a non-profit for public benefit corporation with offices located at 2001 Atlantic Avenue, Long
8 Beach, California 90807 ("Contractor") and the CITY OF LONG BEACH, a municipal
9 corporation ("City") and administering entity for Pacific Gateway Workforce Investment
10 Network.

11 WHEREAS, City and Contractor (the "Parties") entered into Contract No.
12 34622 whereby Contractor agreed to provide customized training for patient care
13 assistants, including work experience hours, to program participants; and

14 WHEREAS, the Parties desire to extend the term and add \$350,000 for a
15 total not to exceed amount of \$670,000;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions herein contained, the Parties agree as follows:

18 1. Section 2.A. of Contract No. 34622 is hereby amended to read as
19 follows:

20 "A. The term of this Contract ("Term") shall be deemed to have
21 commenced as of November 1, 2016, and unless sooner terminated pursuant to the
22 provisions hereof, shall terminate on December 31, 2018. Either of the Parties
23 hereto shall have the right to terminate this Contract in its entirety at any time during
24 the Term for any or no reason whatsoever by giving fifteen (15) days prior written
25 notice of termination to the other party. City shall have the additional right to cancel
26 any part of this Contract at any time during the Term for any reason whatsoever by
27 giving fifteen (15) days' notice of such cancellation to the Contractor."

28 2. Section 5.A. of Contract No. 34622 is hereby amended to read as

1 follows:

2 "A. The total amount which shall be payable by City to Contractor for
3 Contractor's allowable services during the Term shall not exceed Six Hundred
4 Seventy Thousand Dollars (\$670,000)."

5 3. Except as expressly modified herein, all of the terms and conditions
6 contained in Contract No. 34622 are ratified and confirmed and shall remain in full force
7 and effect.

9 be duly executed with all the formalities required by law on the respective dates set forth
10 opposite their signatures.
