A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH RDO EQUIPMENT CO. WITHOUT ADVERTISING FOR BIDS FOR THE PURCHASE OF TWO ROCKLAND BK-M BEACH KING SAND AND BEACH DEBRIS CLEANERS IN AN AMOUNT NOT TO EXCEED \$350,367

WHEREAS, purchase of the new equipment was approved in Fleet Services' FY 19 Vehicle and Equipment Replacement Plan; and

WHEREAS, the Fleet Services Bureau reviewed equipment replacement options with the Parks, Recreation and Marine Department to determine the best equipment for their operational needs; and

WHEREAS, the current units are four years past their useful lives; and

WHEREAS, Rockland Manufacturing Company has authorized RDO Equipment Company (RDO) as the sole source for their equipment in Southern California; and

WHEREAS, RDO is the only provider of large sand debris cleaners of this size and rake configuration; and

WHEREAS, The Rockland Beach King cleaners have proven to be reliable and effective at removal of heavy beach debris; and

WHEREAS, The operators in Beach Maintenance are currently using this equipment and this purchase will allow for continuity of parts, service and operation; and

WHEREAS, as a result, no useful purpose would be served by advertising for bids and to do so would constitute an idle and useless act and an unnecessary

2 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
3 follows:

4 Section 1. The above recitals are true and correct and are incorporated  
5 herein.

6 Section 2. The City Manager is hereby authorized to enter a contract  
7 with RDO EQUIPMENT CO. for the purchase of two Rockland BK-M Beach King sand  
8 and beach debris cleaners, with related equipment and accessories in an amount not to  
9 exceed Three Hundred Fifty Thousand and Three Hundred Sixty Seven Dollars  
10 (\$350,367).

11 Section 3. This resolution shall take effect immediately upon its adoption  
12 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
