

RESOLUTION NO. RES-14-0057

A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH TO TEMPORARILY CLOSE AND
REMOVE FROM PUBLIC USE CERTAIN STREETS,
ALLEYS AND WALKWAYS IN THE CITY OF LONG BEACH
IN CONNECTION WITH THE CONDUCT OF THE 2015
FEDERATION INTERNATIONALE DE L'AUTOMOBILE (FIA)
LONG BEACH ePRIX

The City Council of the City of Long Beach resolves as follows:

Section 1. The City Council of the City of Long Beach finds and determines that the conduct of the 2015 FIA Long Beach ePrix on the streets of the City of Long Beach and the coverage thereof by the media provides a unique opportunity for the City of Long Beach to publicize and call attention to the City, its natural advantage, resources, enterprises, attractions, climate and facilities.

Section 2. For the conduct of the 2015 FIA Long Beach ePrix, the following streets, alleys, and walkways are hereby temporarily closed for the periods stated:

A. From April 3, 2015 at 7:00 a.m. to April 5, 2015 at 12:01 a.m., Seaside Way from Pine Avenue to eastern end of Seaside Way, Linden Avenue from Ocean Boulevard to Seaside Way, Marine Way from Locust Avenue to Collins Way, Atlantic Way from Ocean Boulevard to Seaside Way, Marine Way from Hart Place to eastern end, Linden Avenue, northbound and southbound from Shoreline Drive to Marina Parking lot, Locust Avenue from Ocean Boulevard to Seaside Way, Bay Street at Pine Avenue, and The Paseo at Pine Avenue.

1 B. From April 3, 2015 at 7:00 a.m. to April 5, 2015 at 12:01 a.m.,
2 Shoreline Drive from Ocean Boulevard and Alamitos intersection to Pine
3 Avenue.

4 C. From April 3, 2015 at 7:00 a.m. to April 5, 2015 at 12:01 a.m.,
5 Shoreline Village Drive from Marina Parking lot to Shoreline Drive.

6 D. On April 3 and 4, 2015 from 7:00 a.m. to 7:00 p.m., Pine
7 Avenue from Ocean Boulevard to Upper Esplanade.

8 Section 3. The temporary closing of the above streets, alleys, and
9 walkways, for the times herein provided is necessary for the safety and protection of the
10 participants and spectators in the 2015 FIA Long Beach ePrix and qualifying events to be
11 held from April 3, 2015 through April 4, 2015, utilizing the streets described herein.

12 Section 4. For the period April 3, 2015 at 7:00 a.m. to April 5, 2015 at
13 12:01 a.m., the streets, alleys and walkways described in Section 2.A. are hereby
14 withdrawn and removed from public use.

15 Section 5. For the period April 3, 2015 at 7:00 a.m. to April 5, 2015 at
16 12:01 a.m., the streets, alleys and walkways described in Section 2.B. are hereby
17 withdrawn and removed from public use.

18 Section 6. For the period April 3, 2015 at 7:00 a.m. to April 5, 2015 at
19 12:01 a.m., the streets, alleys and walkways described in Section 2.C. are hereby
20 withdrawn and removed from public use.

21 Section 7. On April 3 and 4, 2015 from 7:00 a.m. to 7:00 p.m., the
22 streets, alleys and walkways described in Section 2.D. are hereby withdrawn and
23 removed from public use.

24 Section 8. The City Manager, or his designee, is authorized and directed
25 to post notices of the intent to temporarily reduce lanes, close the streets, alleys,
26 walkways and portions of the promenade described in Sections 2, 3, 4, 5, 6, and 7 above
27 at least twenty-four (24) hours prior to the closure thereof.

28 Section 9. This resolution shall take effect immediately upon its adoption
