## RESOLUTION NO. RES-19-0025

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO PURCHASE HAND TOOLS, AUTOMOTIVE TOOLS. SPECIALTY TOOLS, HARDWARE AND ITEMS FROM **MISCELLANEOUS** LOWE'S HOME CENTERS, LLC AND W. W. GRAINGER, INC. ON THE SAME TERMS AND CONDITIONS AFFORDED TO REGION 4 EDUCATION SERVICE CENTER THROUGH OMNIA PARTNERS, FORMERLY NATIONAL IPA

WHEREAS, the Charter of the City of Long Beach (the "City"), Section
14 1802, permits the City to purchase services, supplies, materials, equipment and labor
with other government agencies by purchasing under their contracts on a voluntary and
selective basis when authorized by resolution; and

WHEREAS, the City desires to purchase hand tools, automotive tools, specialty tools, hardware and miscellaneous items; and

19 WHEREAS, the Region 4 Education Service Center through the National 20 Intergovernmental Purchasing Alliance has a Contract with Lowe's Home Centers, LLC 21 for the purchase of maintenance, repair and operations, and supplies and related 22 services, Contract No. R142104 ("Lowe's Contract"); and 23 WHEREAS, the Region 4 Education Service Center through the 24 Cooperative Purchasing Network has a Contract with W.W. Grainger, Inc. for the 25 maintenance, repair and operations, and supplies and related services, Contract No. 26 R142102 ("Grainger Contract"); and 27 WHEREAS, the City's participation in the Lowe's and Grainger Contracts 28 will facilitate acquisition of the hand tools, automotive tools, specialty tools, hardware and

1 || miscellaneous items as well as provide considerable cost benefits to the City; and

2 WHEREAS, if the City had to go to formal bid rather than participate in the 3 Lowe's and Grainger Contracts considerably more funds would be required;

4 NOW, THEREFORE, the City Council of the City of Long Beach resolves as 5 follows:

6 Section 1. The above recitals are true and correct and are incorporated
7 herein by this reference.

8 Section 2. The City Manager of the City is hereby authorized to enter into 9 contracts with Lowe's Home Centers, LLC. and W.W. Grainger, Inc., to purchase hand 10 tools, automotive tools, specialty tools, hardware and miscellaneous items of 11 substantially the same type and kind purchased by the Regional 4 Education Service 12 Center through Omnia Partners, formerly National IPA pursuant to the Lowe's and 13 Grainger Contracts except as modified by mutual agreement of the City and Lowe's 14 Home Centers, LLC, and W.W. Grainger, Inc., and the purchase by the City shall be on 15 the same terms and conditions afforded to the Regional 4 Education Service Center 16 through Omnia Partners, formerly National IPA, in a combined annual amount not to 17 exceed Eight Hundred Thousand Dollars (\$800,000) including tax and shipping, for a 18 period of two (2) years, with the option to renew for three (3) additional one-year periods. 19 Section 3. This resolution shall take effect immediately upon its adoption 20 by the City Council, and the City Clerk shall certify the vote adopting this resolution. 21 /// 22  $\parallel \parallel$ 23 111 24 ||| 25 ||| 26 |||
