AN ORDINANCE OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH AMENDING THE LONG BEACH
MUNICIPAL CODE BY AMENDING SUBSECTIONS
10.14.020.A.5 AND 10.14.020.A.7 RELATING TO ONE-
WAY STREETS AND ALLEYS

The City Council of the City of Long Beach ordains as follows:

Section 1. Subsection 10.14.020.A.5 of the Long Beach Municipal
Code is amended to read as follows:

5. (East) Sixth Street, between San Francisco Avenue and
Atlantic Avenue.

Section 2. Subsection 10.14.020.A.7 of the Long Beach Municipal
Code is amended to read as follows:

7. (West) Seventh Street, between southbound De Forest
Avenue and Atlantic Avenue.

Section 3. The City Clerk shall certify to the passage of this ordinance
by the City Council and cause it to be posted in three (3) conspicuous places in the City
of Long Beach, and it shall take effect on the thirty-first (31st) day after it is approved by
the Mayor.


