RECOMMENDATION:

Authorize a public walkways occupancy permit for sidewalk dining at Mykonos Restaurant located at 5374 East Second Street. (District 3)

DISCUSSION

Crabshell Belmont Shore, Inc., the owner of Mykonos Restaurant located at 5374 East Second Street, requests a permit to temporarily occupy part of the adjoining sidewalk for the purpose of sidewalk dining. The proposed permit area and a list of furnishings and accessories to be placed in the permit area are shown on the attached Exhibit A. Approval of this permit is based on the conditions and standards of Chapter 14.14 of the Long Beach Municipal Code, which describes temporary use of public right-of-way. The width of the public sidewalk at this location is 13.5 feet. A minimum clearance of 7 feet shall be maintained between the proposed permit area and the parking meter adjacent to the restaurant.

This permit request was reviewed and approved by the Long Beach Fire Department on May 26, 2006. The subject permit was prepared by Deputy City Attorney Lisa Peskay Malmsten on July 3, 2006.

TIMING CONSIDERATIONS

City Council action on this matter is not time critical.

FISCAL IMPACT

A permit-processing fee of \$500 was deposited to the General Fund (GP) in the Department of Public Works (PW).

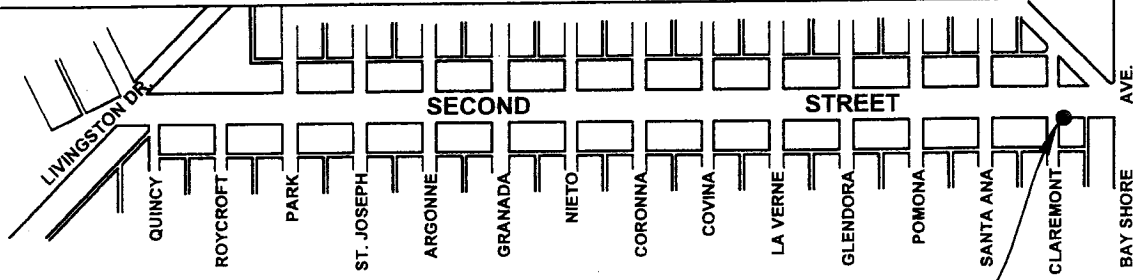

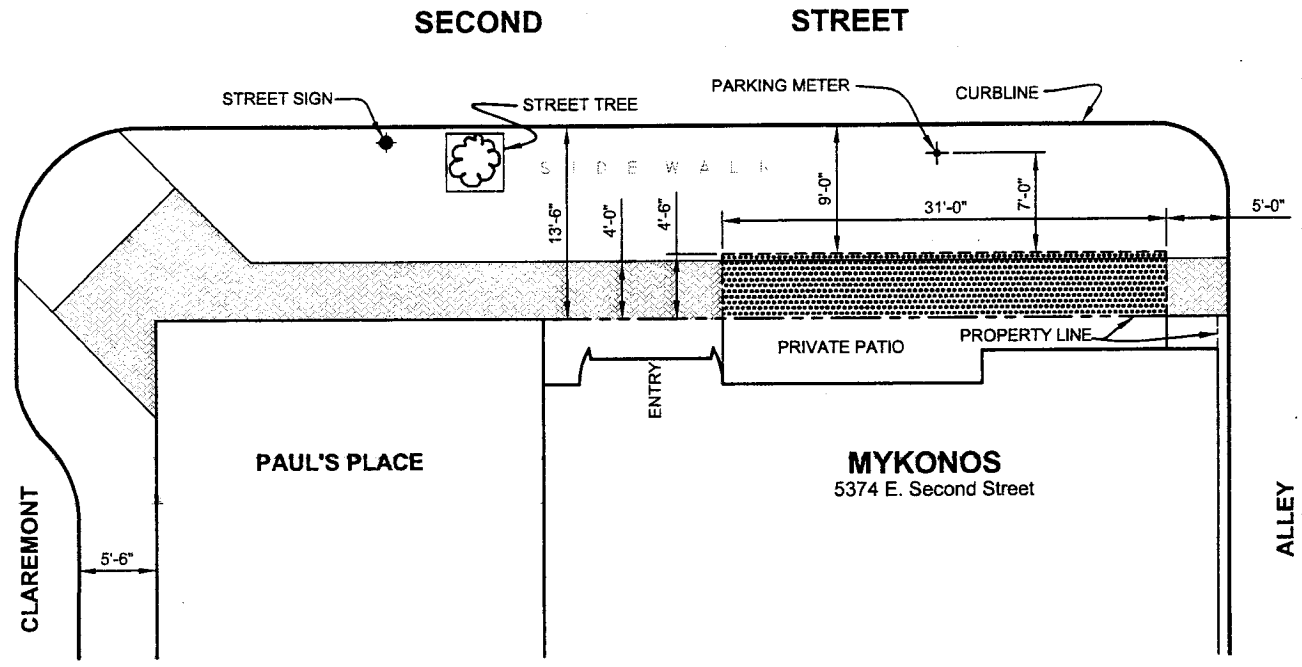
