

FEDERAL GRANT UPDATE

- The Funding level for CDBG increased from \$3.24 billion in FY 18 to \$3.30 billion in FY 19, a 2.0% increase.
- The Funding level for HOME decreased from \$1.362 billion in FY 18 to \$1.250 billion in FY 19, an 8.2% decrease.
