**SUBJECT: Agreement Between the Boeing Company and the City of Long Beach for Use of the Long Beach Police Department Pistol Range (District 5)**

**DISCUSSION**

The Boeing Company (Boeing) would like to enter into an agreement with the City of Long Beach for use of the Police Department Pistol Range for the members of its Executive Protection Program. The Range will be used for qualification and training purposes on an as-needed basis and in compliance with pistol range policies as determined by the Long Beach Police Department.

The Boeing Executive Protection Program currently has five members. Their primary function is to provide executive protection for the dignitaries and executive management members of their company. They are well trained in firearms safety, threat management, surveillance detection and protective intelligence.

The Long Beach Police Department and Boeing have had a long-standing positive working relationship. Boeing has generously included the Long Beach Police Department in executive protection training; approval of their use of the Range will enhance our efforts to participate in joint training exercises. The use of the range by Boeing will not require additional Police Department staff commitment.

This matter was reviewed by Deputy City Attorney Charles Parkin on April 2, 2004 and Budget Manager Michael Killebrew on April 6, 2004.


FISCAL IMPACT

Range use will be provided at no cost to Boeing in exchange for participation in their executive protection training. There is no fiscal impact as a result of this agreement. The Boeing Company will provide all equipment and ammunition. All training will be done during regular range hours when staff is already on-site.

IT IS RECOMMENDED THAT THE CITY COUNCIL:

Authorize the City Manager to execute an agreement and any subsequent amendments with the Boeing Company for use of the Long Beach Police Department Pistol Range, on an as-needed basis, for members of the Executive Protection Program to qualify and train.
