1 FIRST AMENDMENT TO CONTRACT NO. 34724

3 THIS FIRST AMENDMENT TO CONTRACT NO. 34724 is entered into, in
4 duplicate, effective as of June 12, 2019, for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting held on July 18,
6 2017, by and between PURPLE REIGN LIFE SKILLS CENTER LLC, a California limited
7 liability company ("Contractor"), with offices located at 15603 Sandel Avenue, Gardena,
8 California 90248, and the CITY OF LONG BEACH, a municipal corporation ("City") and
9 administering entity for Pacific Gateway Workforce Investment Network.

10 WHEREAS, City and Contractor (the "Parties") entered into Contract No.
11 34724 whereby Contractor agreed to provide various workforce development services to
12 Pacific Gateway and its Board; and

13 WHEREAS, the Parties desire to extend the term of Contract No. 34724 one
14 (1) additional one-year period;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the Parties agree as follows:

17 1. Section 2.A. of Contract No. 34724 is hereby amended to read as
18 follows:

19 "A. The term of this Contract ("Term") shall be deemed to have
20 commenced as of July 1, 2017, and unless sooner terminated pursuant to the provisions
21 hereof, shall terminate on June 30, 2020. Either of the parties hereto shall have the right
22 to terminate this Contract in its entirety at any time during the Term for any or no reason
23 whatsoever by giving fifteen (15) days prior written notice of termination to the other party.
24 City shall have the additional right to cancel any part of this Contract at any time during the
25 Term for any reason whatsoever by giving fifteen (15) days' notice of such cancellation to
26 the Contractor."

27 2. Except as expressly amended herein, all terms and conditions in
28 Contract No. 34724 are ratified and confirmed and shall remain in full force and effect.
