EIGHTH AMENDMENT TO AGREEMENT NO. 33926

THIS EIGHTH AMENDMENT TO AGREEMENT NO. 33926 is made and entered, in duplicate, as of June 7, 2023 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 6, 2023, by and between ARCHITECTS MCDONALD, SOUTAR & PAZ, INCORPORATED, a California corporation ("Consultant"), with a place of business at 3575 Long Beach Boulevard, Long Beach, California 90807, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33926 (the "Agreement") whereby Consultant agreed to provide as-needed architectural services in a total not to exceed amount of Four Hundred Thousand Dollars (\$400,000) for a period of two (2) years with the option to extend for three (3) additional one-year periods; and

WHEREAS, the Parties entered into a First Amendment to extend the term to July 19, 2018; and

WHEREAS, the Parties entered into a Second Amendment to increase the Agreement amount for a total not to exceed Six Hundred Thousand Dollars (\$600,000), and extend the term to July 19, 2019; and

WHEREAS, the Parties entered into a Third Amendment to extend the term of the Agreement to July 19, 2020; and

WHEREAS, on June 9, 2020, City Council approved extending the Agreement by one (1) additional one-year period; and

WHEREAS, the Parties entered into a Fourth Amendment to extend the term of the Agreement to July 19, 2021; and

WHEREAS, on June 8, 2021, City Council approved extending the Agreement one (1) additional one-year period; and

WHEREAS, the Parties entered into a Fifth Amendment to extend the term

2 WHEREAS, the Parties entered into a Sixth Amendment to increase the
3 contract amount for a total not to exceed amount of Eight Hundred Fifty Thousand Dollars
4 (\$850,000), extend the term to July 19, 2023, update the City Representative, and attach
5 an updated rate sheet; and
6 WHEREAS, Parties entered into a Seventh Amendment to increase the
7 authority amount for a total not to exceed One Million Fifty Thousand Dollars (\$1,050,000)
8 to the Agreement; and
9 WHEREAS, on June 6, 2023, City Council approved to extend the term of
10 the Agreement by one (1) additional one-year period; and
11 WHEREAS, the Parties desire to extend the term of the Agreement using the
12 authorized one-year period;
13 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
14 conditions herein contained, the Parties agree as follows:
15 1. Section 2 of the Agreement is hereby amended to read as follows:
16 "2. TERM. The term of this Agreement shall commence at midnight on
17 July 20, 2015, and shall terminate at 11:59 p.m. on July 19, 2024, unless sooner terminated
18 as provided in this Agreement, or unless the services or the Project is completed sooner."
19 2. Except as expressly modified herein, all of the terms and conditions
20 contained in Agreement No. 33926 are ratified and confirmed and shall remain in full force
21 and effect.
