FIRST AMENDMENT TO AGREEMENT NO. 31490

THIS FIRST AMENDMENT TO AGREEMENT NO. 31490 is made and entered, in duplicate, as of October 30, 2010 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on November 17, 2009, by and between FORENSIC NURSING SPECIALISTS, INC., doing business as FORENSIC NURSE SPECIALISTS ("Contractor"), with a place of business at 3435 Cerritos Avenue, Los Alamitos, California 90720, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires assistance to provide medical examinations, evidence collection, and appropriate treatment with respect to victims of sexual assault; and

WHEREAS, the parties executed Agreement No. 31490 in January of 2010 wherein Contractor agreed to provide medical services required by the City at a reasonable cost for a term of one (1) year; and

WHEREAS, now the parties desire to extend the term for an additional year;

NOW, THEREFORE, in consideration of the mutual terms, covenants and conditions herein, the parties agree as follows:

1. Section 2 of Agreement No. 31490 is hereby amended and deleted in its entirety to read as follows:

"2. The term of this Agreement shall commence at midnight on November 1, 2009 and shall terminate at 11:59 p.m. on October 30, 2011. City shall have the option to extend the term of this Agreement for one (1) additional year, upon authorization by the City Manager."

2. Except as expressly stated herein, all of the terms, covenants, and conditions of Agreement No. 31490 are ratified and confirmed and shall remain in full force and effect.
