

Resolution to Authorize a Contract With ProForce Marketing, Inc., to

Purchase Taser Equipment and Accessories (Citywide)

DISCUSSION

The Police Department is requesting authorization to enter into a contract for the purchase of taser equipment and accessories from ProForce Marketing, Inc. The purchase of tasers will provide police officers with a less-lethal alternative to the use of their service weapon. ProForce Marketing, Inc., is the sole authorized taser distributor to police departments for Southern California.

In March 2004, the City purchased 94 tasers. An additional 260 tasers and accessories are requested to increase the number of officers equipped to respond with a less-lethal weapon when confronted with violent and non-compliant subjects. It is the intention of the Police Department to eventually provide tasers to all sworn officers. The Police Department estimates needing an additional 235 tasers to accomplish this.

This matter was reviewed by Senior Deputy City Attorney Donna F. Gwin on July 12, 2004 and by Budget Management Officer David Wodynski on July 16, 2004.

TIMING CONSIDERATIONS

City Council action to adopt the attached Resolution and award the contract concurrently is requested on August 3, 2004 to expedite the purchase of less-lethal equipment for police officers.

FISCAL IMPACT

The total cost of this purchase will not exceed \$284,000. This expenditure is included in the Police Department's estimate to close for the current fiscal year and will be funded by the General Fund (PD 301) in the amount of \$194,615 and the Local Law Enforcement Block Grant VIII in the amount of \$89,385, which includes a 1 percent City match.

Adopt the attached Resolution authorizing the City Manager to execute a contract with ProForce Marketing, Inc., for the purchase of taser equipment and accessories in an amount not to exceed \$284,000.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY
OF LONG BEACH AUTHORIZING THE CITY MANAGER TO
EXECUTE, ON BEHALF OF THE CITY, A CONTRACT WITH
PROFORCE MARKETING, INC. DOING BUSINESS AS
PROFORCE LAW ENFORCEMENT, WITHOUT ADVERTISING
FOR BIDS FOR FURNISHING TASERS

WHEREAS, in April, 2004, the Long Beach Police Department purchased X26 tasers and now desires to purchase additional tasers of the same make and model; and

WHEREAS, standardization will enable training and maintenance to be efficient and cost effective; and

WHEREAS, as a result, no useful purpose would be served by advertising for bids and to do so would constitute an idle and useless act and an unnecessary expenditure of public funds because ProForce Marketing, Inc., doing business as ProForce Law Enforcement, is the only California dealer authorized by the manufacturer, Taser International, to sell the X26 taser;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. That the above recitals are true and correct and are incorporated herein by this reference.

Sec. 2. The City Manager is hereby authorized to execute a contract with ProForce Marketing, Inc., doing business as ProForce Law Enforcement, to purchase an additional 260 tasers in an amount not to exceed \$284,000.00, including self-accrual of tax.

Sec. 2. This resolution shall take effect immediately upon its adoption by the
