1. CALL TO ORDER

Chair Reyes Uranga called the meeting to order.

2. OPENING REMARKS

Chair Reyes Uranga made opening remarks and thanked Councilmembers Lowenthal and Lerch for their commitment to the long-term process. Councilmember Lowenthal advised that the maps on display had a reconfigured downtown 3rd Street freeway exit, and Councilmember Lerch advised that the freeway had been reconfigured in North Long Beach in the vicinity of the Sutter Academy and Los Cerritos Elementary School neighborhoods in response to expressed concerns. Chair Reyes Uranga advised that as the process proceeds through the other agencies, the public will continue to have opportunities to comment and articulate observations on potential neighborhood impacts, such as before the Tier Two Committee, Gateway Cities Council of Governments, the Oversight Policy Committee, and at the stage when the Environmental Impact Report is presented prior to breaking ground for construction in 10 to 13 years.

3. REPORT ON THE CIRCULATION OF THE DRAFT LOCALLY PREFERRED STRATEGY ACTIONS:

- (1) Receive and file recommended changes to the Draft Locally Preferred Strategy.
- (2) Receive and file Community Recommendations sorted by category.
- (3) Schedule an I-710 Oversight Committee Town Hall Meeting on Wednesday, May 19, 2004, to review the Draft Locally Preferred Strategy for the Improvement of the I-710 Freeway.

Lee D. Ward, Principal with Meyer, Mohaddes Associates, 400 Oceangate, Suite 480, Long Beach, articulated that since March 18, 2004, five community meetings were held where general discussions had taken place, questions were taken, and the freeway expansion plans displayed to enable residents to view and express design concerns in relation to their neighborhoods. Support of Port efforts to reduce diesel fuel emissions and the Gateway Cities Council of Governments Program to reduce truck emissions were endorsed. Findings from the neighborhood community meetings are synopsized below:

Wrigley Association, April 5, 2004, Veterans Park:

Two major concerns emerged, that of right-of-way/housing acquisitions and double decking. The message concerning double-decking was heard, but double decking is included in one section of the freeway in order to preserve homes. However, the consensus was that the truck lanes on the bottom would be lowered so the upper level for the cars would be closer to the existing ground level elevation.

Pro-West Neighbors United, April 7, 2004, Cabrillo High School:

Recommendations to remove or diminish the source of diesel pollutions should be carried forward. Pedestrian and traffic safety concerns were discussed with Thomas Edison School, and the geometric design for 7th Street east of Magnolia Avenue changed to enhance safety for pedestrian crossing and drop-offs.

West End Community Association, April 8, 2004, Cesar Chavez Park:

Three alternatives for the third street ramp were considered, and Alternative 3 which provides connections for 3rd Street to both Shoreline Drive south and the freeway north was the unanimous choice.

Coolidge Triangle Homeowners Association:

(1) Three houses could lose a "sliver" (4-5') of their back yard, although design refinements will continue to be reviewed. (2) The "slivers" could be saved by going substandard shoulder widths or other substandard widths including the eastbound car pool lane. Caltrans will decide if "design exceptions" are appropriate. (3) Consideration to redesign in order to move the mainline freeway west between the 405 and Long Beach Boulevard Interchange, where homes are located closer to the freeway on the east side rather than the west side. (4) The 74 previous community recommendations include 30 which are designed to stop air pollution at its source rather than push polluters around.

Councilmember Lowenthal moved, seconded by Councilmember Lerch, that the recommended changes to the Draft Locally Preferred Strategy be received and filed. Carried by unanimous vote.

4. PUBLIC COMMENT

John Applequist, 175 W. Plymouth, spoke and submitted a petition signed by Stacey Aravelo, et al. (130 names), stating that the people of the Sutter School neighborhood (located west of Long Beach Boulevard and east of the I-710 Freeway oppose the current plan to expand the I-710 by adding 4 new diesel truck-only areas in a previously undeveloped utility right-of-way.

Kerry Ugalini, 613 W. 36th Street, pointed out that one ramp going from the I-710 to the southbound I-405 cuts through the oil operator properties north of Baker Street and questioned whether they would still be held to Environmental Impact Report remediation provisions or if Caltrans would purchase the land; and further commented that Wardlow Road, a major east-west thoroughfare (not shown on the map), would have to be addressed in the freeway expansion plan because it over-spans the freeway.

Laurie Angel, 458 E. Platt Street, stated that freeway expansion is proportionate to Port expansion, and called for formation of a citizen advisory committee on the Port to discuss issues so the Port could improve its community approval rating. She suggested mitigation measures be enacted for additional parkland, greenbelts, trees, safe bike lanes, and soundwalls, where reasonable, because residents along the I-710 absorb impacts due to the Alameda Corridor not being developed as originally proposed.

Rob Webb, Councilmember, Eighth District, advised that after viewing aerial maps and discussions with engineers it is possible to move the freeway centerline westward to an old abandoned railroad right-of-way to lessen neighborhood impacts and then lower truck lanes to eliminate the need for overpasses for the Metro Blue Line and Del Amo Boulevard; and announced two Town Hall meetings on May 10, 2004, at Sutter Academy, at 6:30 P.M.; and May 12, 2002, at Los Cerritos Elementary, at 6:30 P.M. to discuss freeway strategies.

Dave San Jose, 202 E. Bort Street, spoke in support of legislation introduced by Assemblymember Alan Lowenthal in February promoting pollution reform by cutting emissions from the ports.

Roger Holman, 310 E. Forhan Street, Coolidge Triangle Association, suggested that each of the 74 ideas from the community be addressed.

Allen Hose, 3595 Santa Fe Avenue, No. 251, Tier Two Committee, a group of community members who represent the City at Oversight Policy Committee meetings, reported that the overriding concerns at a Tier Two Committee held in the City of Carson were those of port expansion and air quality, and urged proactive measures that support legislation to propel momentum forward in a positive direction.

Adrian Garcia, 115 Pine Avenue, No. 430, reaffirmed the position and legislation introduced by Assemblymember Alan Lowenthal, 54th District, as follows: AB2041, that imposes a fee for trucks carrying cargo into or out of the two ports from 8:00 A.M. to 5:00 P.M., Monday through Friday; AB2042, that requires the ports to adhere to no net increase in air pollution when planning for development or expansion; and AB2043, that looks at the entire State goods movement structure and sets up a California Maritime Strategic Port Master Plan Task Force to look at issues facing California ports.

Councilmember Lowenthal moved, seconded by Councilmember Lerch, that the Community Recommendations sorted by category be received and filed. Carried by unanimous vote.

Councilmember Lerch moved, seconded by Councilmember Lowenthal, that an I-710 Oversight Committee Town Hall Meeting be scheduled for Wednesday, May 19, 2004, Long Beach Energy Department, 2400 E. Spring Street, to review the Draft Locally Preferred Strategy for the Improvement of the I-710 Freeway. Carried by unanimous vote.

5. NEXT STEPS

Chair Reyes Uranga encouraged the public to attend the meetings that were announced to give input on the revised strategies that would be advanced based on comments received, afterwhich a final I-710 Oversight Committee would be held prior to forwarding the Locally Preferred Strategy to the City Council.

2. OPENING REMARKS

Chair Reyes Uranga thanked Pepper Russell, Chair of the West End Community Association, for hosting the I-710 Oversight Committee at its monthly meeting and recognized City staff associated with the Committee.

- 3. PRESENTATION OF LONG BEACH DRAFT LOCALLY PREFERRED STRATEGY TO IMPROVE THE I-710 FREEWAY. THE STRATEGY WAS BASED ON WRITTEN AND ORAL PUBLIC COMMENTS RECEIVED DURING PREVIOUS COMMUNITY MEETINGS AND PUBLIC WORKSHOPS.
 - GUIDING PRINCIPLES AND KEY ISSUES
 - SYSTEMS APPROACH COMMUNITY CONDITIONS OF APPROVAL
 - DESIGN CONCEPTS

Sumi Gant, Acting Manager-Traffic and Transportation Bureau, Public Works Department, advised that the Locally Preferred Strategy would be presented for review and gave an overview on the progress of the I-710 Oversight Committee and issues discussed that will be used in developing the Community Conditions for Approval.

Lee D. Ward, Professional Engineer with Meyer, Mohaddes Associates, 400 Oceangate, Suite 480, Long Beach, reviewed design concepts as illustrated on the Draft Locally Preferred Strategy Map, dated March 18, 2004, that was posted for review purposes and highlighted strategy points related to Port diesel emissions improvements, truck diesel emissions improvements, an enhanced Alameda Corridor, "on-dock" rail, local street improvements, and traffic signal enhancements. It was pointed out that in order to eliminate the need to take homes, different sections along the I-710 Freeway Corridor were designed based on the design concepts approved by the Committee, including eliminating unnecessary truck ramps at the 91 Freeway interchange, utilizing the space between the existing freeway and the Los Angeles River to add capacity, separating cars from trucks atgrade for increased safety wherever possible, modifying existing freeway onramps and offramps to use "diamond" designs where possible to minimize right-of-way impacts and expand opportunities for green space, eliminating the Terminal Island Freeway extension to the I-710 Freeway, and redesigning the Shoemaker Bridge and realigning the ramps into

downtown Long Beach to expand Cesar Chavez Park. The systems approach used in this design includes addressing the community's recommendation to improve air quality, and to reduce truck congestion on the 710 by supporting ACTA's efforts to connect the Terminal Island Freeway to the Alameda Corridor.
