RECOMMENDATION:

Authorize the City Manager to execute a Public Walkways Occupancy Permit for sidewalk dining at Hole Mole Restaurant located at 2125 Bellflower Boulevard. (District 4)

DISCUSSION

Scott Bascon, owner of Hole Mole Restaurant located at 2125 Bellflower Boulevard, requests a permit to temporarily occupy part of the adjoining sidewalk for the purpose of sidewalk dining. The proposed permit area and a list of furnishings and accessories to be placed in the permit area are shown on the attached Exhibit A. Approval of this permit is based on the conditions and standards of Chapter 14.14 of the Long Beach Municipal Code which describes temporary uses of public right-of-way. The width of the sidewalk is 12 feet. A minimum clearance of 6 feet will be maintained between the permit area and the curb.

This permit request was reviewed and approved by the Long Beach Fire Department on January 7, 2009. Deputy City Attorney Linda Trang prepared the subject permit on January 22, 2009.


FISCAL IMPACT

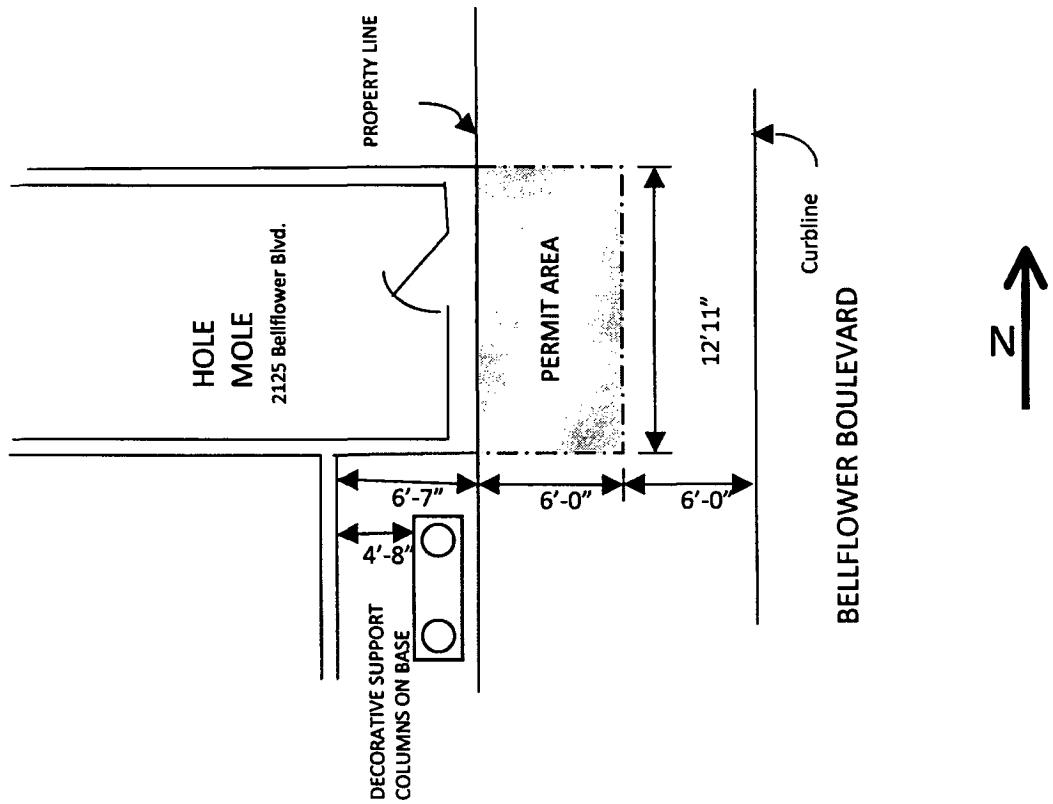
