3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO ACQUIRE TWENTY (20) ELGIN PELICAN
6 STREET SWEEPERS, WITH THE OPTION TO PURCHASE
7 ADDITIONAL ELGIN PELICAN STREET SWEEPERS,
8 THROUGH THE CONTRACT BETWEEN THE STATE OF
9 OREGON AND HAAKER EQUIPMENT COMPANY
10

11 WHEREAS, the Charter of the City of Long Beach (the "City"), Section
12 1802, permits the City to purchase services, supplies, materials, equipment and labor
13 with other government agencies by purchasing under their contracts on a voluntary and
14 selective basis when authorized by resolution; and

15 WHEREAS, the City desires to purchase twenty (20) Elgin Pelican street
16 sweepers with the option to purchase additional Elgin Pelican street sweepers; and

17 WHEREAS, the State of Oregon has a contract for the purchase of these
18 street sweepers from Haaker Equipment Company, Contract No. 6835 ("Oregon
19 Contract"); and

20 WHEREAS, the City's participation in the Oregon Contract will facilitate
21 acquisition of these street sweepers as well as provide considerable cost benefits to the
22 City; and

23 WHEREAS, if the City had to go to formal bid rather than participate in the
24 Oregon Contract considerably more funds would be required;

25 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
26 follows:

27 Section 1. The above recitals are true and correct and are incorporated
28 herein by this reference.

1 Section 2. The City Manager of the City is hereby authorized to enter an
2 agreement with Haaker Equipment Company to purchase twenty (20) Elgin Pelican street
3 sweepers, with the option to purchase additional Elgin Pelican street sweepers, of
4 substantially the same type and kind purchased by the State of Oregon pursuant to the
5 Oregon Contract except as modified by mutual agreement of the City and Haaker
6 Equipment Company, and the purchase by the City shall be on the same terms and
7 conditions afforded to the State of Oregon in an amount not to exceed \$4,336,295.00,
8 including tax, with a 10% contingency for additional equipment, for a period extending
9 until the warranty on the street sweepers expires.


10 Section 3. This resolution shall take effect immediately upon its adoption
11 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
