3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH IMPLEMENTING GOVERNMENT  
5 CODE SECTION 20636(c)(4) PURSUANT TO SECTION  
6 20691 BY PAYING AND REPORTING THE VALUE OF  
7 EMPLOYER PAID MEMBER CONTRIBUTIONS FOR POLICE  
8 SAFETY MANAGERS REPRESENTED BY THE LONG  
9 BEACH MANAGEMENT ASSOCIATION TO THE  
10 CALIFORNIA PUBLIC EMPLOYEES' RETIREMENT SYSTEM  
11 (CalPERS)

13 WHEREAS, the City of Long Beach has the authority to implement  
14 Government Code Section 20636(c)(4) pursuant to Section 20691; and

15 WHEREAS, the City of Long Beach has a written labor policy or  
16 agreement which specifically provides for the normal member contributions to be paid  
17 by the employer, and reported as special compensation; and

18 WHEREAS, one of the steps in the procedures to implement this section  
19 is the adoption by the governing body of the City of Long Beach of a resolution giving  
20 notice of its intention to commence paying and reporting the value of employer paid  
21 member contributions (EPMC) as compensation for all members of the group or class  
22 as identified herein.

23 NOW, THEREFORE, the City Council of the City of Long Beach resolves  
24 as follows:

25 Section 1. Effective as of April 1, 2006, the governing body of the City of  
26 Long Beach shall implement Government Code Section 20636(c)(4) pursuant to  
27 Section 20691 by paying and reporting the value of Employer Paid Member  
28 Contributions (EPMC) for Police Safety Managers represented by the Long Beach

1 Management Association. This benefit shall consist of the City paying 8% of the normal  
2 contributions as EPMC, and reporting the same percent value of compensation  
3 earnable, excluding special compensation pursuant to Government Code Section  
4 20636(c)(4) as additional compensation. The employee shall pay 1% of the normal  
5 contribution. Effective April 1, 2007, this benefit shall consist of the City paying 7% and  
6 the employee paying 2%.



8 Sec. 2. This resolution shall take effect immediately upon its adoption by  
9 the City Council, and the City Clerk shall certify to the vote adopting this resolution.
