

ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH AMENDING THE LONG BEACH
MUNICIPAL CODE BY AMENDING SECTION 10.22.080
BY ADDING SUBSECTION AA RELATING TO PARKING
VEHICLES FOR SALE

WHEREAS, the City has received numerous complaints from citizens
regarding the parking of vehicles with "For Sale" signs on Seventh Street between
Redondo Avenue and Park Avenue, on Second Street between Livingston Drive and
Ximeno Avenue, on Bellflower Boulevard between Conant Street and Spring Street,
including service roads parallel thereto, and on Del Amo Boulevard between Clark
Avenue and Woodruff Avenue; and

WHEREAS, with the increase of vehicles parking with "for sale" signs on
them in the areas described above, such activity is creating unsafe traffic conditions
because motorists interrupt traffic flow to stop or slow down to observe the vehicles
displaying "for sale" signs which creates the potential for traffic collisions.

NOW THEREFORE, the City Council of the City of Long Beach ordains as
follows:

Section 1. Section 10.22.080 of the Long Beach Municipal Code is
hereby amended by adding Subsection AA to read as follows:

AA. Seventh Street between Redondo Avenue and Park Avenue,
Second Street between Livingston Drive and Ximeno Avenue, Bellflower
Boulevard between Conant Street and Spring Street, including the
service roads parallel thereto, and Del Amo Boulevard between Clark
Avenue and Woodruff Avenue.

Sec. 2. The City Clerk shall certify to the passage of this ordinance by the
