

Thank you for creating this important opportunity to support a Digital Inclusive City. I am in support of each component: participation in the NDIA, Recycle, Innovation and Patents. And with that a request that personal identity protection is part of each of these strategies. Personal identity protection for threats that are known and those not yet developed would help increase participation, and thus effectiveness. In addition, it is important that the City of LB be an active member of the NDIA e.g. with its current efforts to retain the LifeLine program - key to protection of vulnerable programs.


Here are some situations that I encounter routinely in my neighborhood and older adult work in the city of Long Beach. These might help shape the discussion and understanding of the importance of digital capability and access.

The homeless student - We have students in our neighborhood mentoring program that are homeless or lack permanent housing. They need to have daily access to their work effort "their portfolio). A cloud based solution would be useful. Further, if in high school they need to see their LBUSD status - a key to successful mentoring.

The older adult - there is no one group of older adults. But we have very low income older adults who need their household income for medications or to support grandchildren. A computer and a monthly cable fee is outside that budget. Everyone in the household needs access to thrive in their pursuits. For older adults in senior buildings - free Wi-Fi should be required. There are existing programs offered around the city "Tech Workshops" for older adults. These have been designed to assist those with limited English, limited literacy, limited hearing and limited vision. In-home training and set up by Senior Police Partners or other 'vetted' groups is warranted.

The renter - My neighborhood is a renter majority neighborhood, as are other neighborhoods. This will only increase. There is no single way to communicate and interact between our 'home-renters' and the larger community. I support incentives for property owners of multi-units, especially those in targeted use/geographical communities to include free Wi-Fi. There is also a gap in areas where there are no library or community centers. In these areas the use of business center model where businesses in a mixed use or commercial area are provided a public Wi-Fi system could strengthen the neighborhood.
