THIS FIRST AMENDMENT TO AGREEMENT NO. 35810 is made and entered, in duplicate, as of January 3, 2023 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 5, 2021, by and between PLATT SECURITY SYSTEMS, INC., a California corporation ("Contractor"), with a place of business at 3275 E. Grant Street, Suite B, Signal Hill, California 90755, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed video surveillance installation, repair, and maintenance to new and existing systems; and

WHEREAS, the Parties currently desire to extend the term of the Agreement for one additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2. of the Agreement is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on January 5, 2021, and shall terminate at 11:59 p.m. on January 4, 2024, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be renewed for two (2) additional one-year periods."

2. Except as expressly modified herein, all of the terms and conditions contained in this Agreement are ratified and confirmed and shall remain in full force and effect.

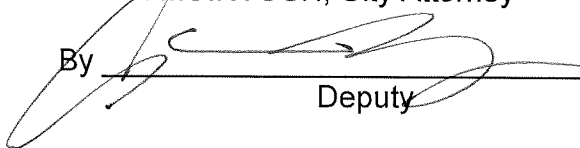
