3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO PURCHASE FURNITURE SYSTEMS
6 THROUGH THE CONTRACT BETWEEN THE COUNTY OF
7 FAIRFAX, VIRGINIA AND KNOLL, INC., A PARTICIPANT IN
8 THE U.S. COMMUNITIES GOVERNMENT PURCHASING
9 ALLIANCE

11 WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the
12 City to purchase services, supplies, materials, equipment and labor with other government
13 agencies by purchasing under their contracts on a voluntary and selective basis when
14 authorized by resolution; and

15 WHEREAS, the City of Long Beach desires to purchase furniture systems;
16 and

17 WHEREAS, the County of Fairfax, Virginia has a contract for the purchase
18 of these items ("Fairfax Contract No. RQ01-411313-16A"); and

19 WHEREAS, City's participation in Fairfax Contract No. RQ01-41131-16A will
20 facilitate acquisition of these items as well as provide considerable costs benefits to the
21 City; and

22 WHEREAS, if the City had to go to formal bid rather than participate in
23 Fairfax Contract No. RQ01-411313-16A considerably more funds would be required;

24 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
25 follows:

26 Section 1. The above recitals are true and correct and are incorporated by
27 this reference.

4 mutual agreement of the City of Long Beach and the vendor of these items and the
5 purchase by the City of Long Beach shall be on the same terms and conditions afforded
6 to the County of Fairfax, Virginia in an amount not to exceed \$485,000.00 including tax
7 and extras, for a period extending until the warranty expires.

8 Sec. 3. This resolution shall take effect immediately on its adoption by the
9 City Council, and the City Clerk shall certify the vote adopting this resolution.
