FIRST AMENDMENT TO AGREEMENT NO. 33879

**33879**

THIS FIRST AMENDMENT TO AGREEMENT NO. 33879 is made and entered, in duplicate, as of May 30, 2017, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on May 19, 2015, by and between CONVERGEONE, INC., a Minnesota corporation formerly known as SIGMANET, INC. ("Consultant"), with a place of business located at 4290 E. Brickell Street, Ontario, CA 91761, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with personal computer replacement and installation services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33879 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, on December 4, 2015, SigmaNet Inc. was acquired by ConvergeOne, Inc. and operates as a wholly-owned subsidiary of ConvergeOne, Inc.; and

WHEREAS, the Parties desire to extend the term of the Agreement for an additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:  
"2. TERM. The term of this Agreement shall commence at midnight on June 1, 2015, and shall terminate on May 31, 2018, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. This Agreement may be renewed for one (1) additional one-year period at the discretion of the City Manager."
2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33879 are ratified and confirmed and shall remain in full force and effect.
