
ADDENDUM TO ON-AIRPORT LEASE 1 DATED MARCH 22, 2005 2 BETWEEN THE U.S. DEPARTMENT OF TRANSPORTATION 3 FEDERAL AVIATION ADMINISTRATION 4 30563 5 The following correction and change is made to the On-Airport Lease dated 6 JULY as of March 22, 2005 ("Lease"), between the U.S. Department of Transportation, 7 Federal Aviation Administration (the "Government") and the City of Long Beach, a 8 9 municipal corporation (the "City"): 1 A new Section 18 shall be and hereby is added to the Lease to be and 10 11 read as follows: 12 "18. INDEMNIFICATION In accordance with and subject to the conditions, limitations and exceptions 13 set forth in the Federal Tort Claims Act of 1948, as amended (28 USC 2671 et. seq.), 14 15 hereafter termed the 'Act' the Government will be liable to persons damaged by any 16 personal injury, death or injury to loss of property, which is caused by a negligent or wrongful act or omission of an employee of the Government while acting within the scope 17 18 of his office or employment under circumstances where a private person would be liable 19 in accordance with the law of the place where the act or omission occurred. The foregoing 20 shall not be deemed to extend the Government's liability beyond that existing under the Act 21 at the time of such act or omission or to preclude the Government from using any defense 22 available in law or equity." 23 By executing this Addendum, the parties acknowledge the above change and TIIT.Y ratify the On-Airport Lease dated March 22, 2005, between the U.S. DEPARTMENT 24 25 11 26 11 27  $\parallel$ 28 11
