

1 SIXTH AMENDMENT TO AGREEMENT NO. 34109

3 THIS SIXTH AMENDMENT TO AGREEMENT NO. 34109 is made and  
4 entered, in duplicate, as of November 30, 2020, for reference purposes only, pursuant to  
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 November 17, 2020, by and between PACIFICA SERVICES, INC., a California corporation  
7 ("Consultant"), with a place of business at 106 South Mentor Avenue, Pasadena, California  
8 91106, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.  
10 34109 (the "Agreement") whereby Consultant agreement to provide as-needed  
11 professional compliance monitoring services; and

12 WHEREAS, the Parties entered into a First Amendment to the Agreement to  
13 revise the rate schedule and update the name of the City Representative; and

14 WHEREAS, the Parties entered into a Second Amendment to the Agreement  
15 to revise the rate schedule; and

16 WHEREAS, the Parties entered into a Third Amendment to the Agreement  
17 to add \$200,000 for a total not to exceed amount of \$440,000, revise the rate schedule and  
18 extend the term to November 14, 2019; and

19 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement  
20 to add \$1,348,161 for a total not to exceed amount of 1,788,161; and

21 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to  
22 add \$1,260,000 for a total not to exceed amount of \$3,048,161, extend the term to  
23 November 14, 2020 and attach an updated rate sheet; and

24 WHEREAS, the Parties desire to extend the term one (1) additional two-year  
25 period;

26 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
27 conditions herein contained, the Parties agree as follows:

28 1. Section 2 of the Agreement is hereby amended to read as follows:

1 "2. TERM. The term of this Agreement shall commence at midnight on  
2 November 15, 2015, and shall terminate at 11:59 p.m. on November 14, 2022, unless  
3 sooner terminated as provided in this Agreement, or unless the services or the Project is  
4 completed sooner."

5 2. Except as expressly modified herein, all of the terms and conditions  
6 contained in Agreement No. 34109 are ratified and confirmed and shall remain in full force  
7 and effect.
